ORDINANCE ZONING THE MUNICIPALITY OF OTON, ILOILO AND CLASSIFYING THE SHORELINES OF BRGY. ALEGRE, BOUNDARY OF AREVALO TO BRGY. CABANBANAN, BOUNDARY OF TIGBAUAN AS TOURIST/COMMERCIAL/INDUSTRIAL ZONE.

WHEREAS, the zoning of the Municipality of Oton would contribute to the general satisfaction and comfort of our people, businessmen, landowners, investors, and tourists;

WHEREAS, the areas along Brgy. Alegre, boundary of Arevalo to Brgy. Cabanbanan, boundary of Tigbauan has been previously zoned thru an existing old ordinance as tourist zone, thus restricting the people and other interested investors to put-up different kinds of businesses along these areas and also caused the seizure of some businesses already existing;

WHEREAS, this body, thru research and recommendations, found out that these areas could turn-out to be a good industrial/commercial zone notwithstanding its previous classification as a tourist zone.

NOW THEREFORE, on motion of Hon. Antonio Ecube and Hon. Ernesto Templanza, and unanimously seconded, be it

SECTION 1 - That the whole shoreline of this municipality be zoned for appropriate purposes and programs.

SECTION 2 - That the areas along Brgy. Alegre boundary of Arevalo to Brgy. Cabanbanan, boundary of Tigbauan be re-classified as Tourist/Commercial/Industrial zone.

SECTION 3 - That previous/Ordinance/Resolution/provision in consistent with this Ordinance shall be deemed amended or repealed.


SECTION 4 - That this Ordinance shall take effect immediately upon approval.


