ORDINANCE NO. 31
Series of 1994

ORDINANCE REQUIRING ALL OPERATORS OF TRICYCLES-FOR-HIRE (MCH) TO PRINT THE OMFEB NUMBER AT THE FRONT, REAR AND RIGHT SIDE OF THEIR UNITS.

ON MOTION OF Hon. Jose Neil P. Olivares and duly seconded by Hon. Rene S. Escanlar, Hon. Eusebio G. Villavicencio, Jr. and Hon. Neomedea C. Guillergan,

BE IT ORDAINED by the Sangguniang Bayan of Oton in its Regular Session that:

D SECTION 1 - All operators of Tricycles-For-Hire (MCH) operating within the Municipality of Oton shall be required to print the OMFEB Number at the front, rear and right side of their units.

R SECTION 2 - PRINTING OF OMFEB NUMBER SHALL BE:

- R*
- At the front, rear and right side of an MCH unit.
 - Printed in letters and numbers which shall not be less than three (3) and not more than five (5) inches in length.
 - Readable within the twenty-meter distance.
 - Placed inside a rectangle.

SECTION 3 - Once no ample space is available in an MCH unit, the operators shall print the OMFEB Number in a plate, following the provisions of Section 2 hereof.

SECTION 4 - PENALTY CLAUSE.

An MCH unit operating without a printed OMFEB Number at the portions designated herein shall be impounded at the Oton PNP Station and shall only be released after the operator paid a fine of Two Hundred (P200.00) Pesos or after operator's imprisonment of eight (8) hours.

SECTION 5 - REPEALING CLAUSE.

Any Ordinance inconsistent herewith is hereby repealed.

SECTION 6 - EFFECTIVITY CLAUSE.

- a. This Ordinance shall take effect after Ten (10) days of posting in at least Two (2) conspicuous places.
- b. Nevertheless, upon the effectivity of this Ordinance, there shall be a grace period of one (1) week to be counted from the date of effectivity for Section 3 to apply.


