ORDINANCE NO. 12
 Series of 1994

ORDINANCE PRESCRIBING SPECIFIC ROUTES OF TRICYCLES FOR HIRE (MCH) AMENDING SECTION 2, ARTICLE V OF MUNICIPAL ORDINANCE NO. 12, SERIES OF 1992 AND ISSUE REGULATIONS FOR THIS PURPOSES.

IN SUPPORT of Sen. Jose Neil P. Olivares which was seconded by Sen. Rene S. Manjar, Sen. Danilo B. Dalisay and Sen. Francisco C. Magalana, be it

ORDAINED by the Sangguniang Bayan of Oton during its regular Session that:

SECTION 1 - TO ADOPT SPECIALIZATION OF MCH OPERATION AND A CONCENTRATED PUBLIC UTILITY SERVICES, THE FOLLOWING SHALL BE THE ROUTES OF MCH WHICH SHALL ONLY BE AVAILABLE FOR OPERATION AND THE APPLICATION OF NTOP:

- a. Lambuyan - Abilay Sur/Norte - Pulo Maestra Vito
- b. Tagbas Sur/Norte - Tuburan - Bita Sur
- c. Mangog - Abilay Norte
- d. Sta. Rita - Cadiang - Salugan
- e. Sta. Rita - Sta. Maxima - Rizal - Sta. Clara
- f. Sumbaluden - Batuan Island/Ilaya - Cadiang - Turog-Turog
- g. Bury
- h. Poblacion
- i. Alegre
- j. Galan-daan
- k. Cagbang - Sakind

SECTION 2 - No MCH unit shall be allowed to operate in a route other than the route specified in the Motorized Tricycles' Operators' Permit (NTOP) unless hired for private use.

SECTION 3 - Operators shall be required to print the penal route of their units at the front and side portions of every unit. The size of letters shall be uniform with that of the OOTPS Number.

SECTION 4 - MCH Units Operating in specified routes (as printed in the NTOP) before and during the enactment of this Ordinance shall be deemed operating legitimately in their specific route. They may continually operate in their routes provided the route conforms with Section 1 or Section 2 hereof.

*** NEXT ***

SECTION 2 - There shall be no dual route for an MHE unit, with reference to Section 2 hereof.

SECTION 4 - There shall be a renewal or amendment of Provisional Authority to operate MHE units on routes, in which operators shall renew or amend the route of their units within one (1) month from the date of expiration of this Ordinance.

SECTION 7 - There shall be a filing fee of Thirty Dollars (\$30.00) in cases falling under the preceding section.

SECTION 8 - Drivers of MHE Units are duty bound to transport passengers who are counting along their line of operation, even though the borough or city is not mentioned in the provision on route filed with CMVH.

SECTION 9 - PENALTY CLAUSE.

a. An operator whose MHE unit's operation violates Section 2 hereof shall pay a fine of Three Hundred Dollars (\$300.00) or ten days imprisonment or both upon the discretion of the court. Upon apprehension, the unit shall be impounded at the 6th FHP Station and shall only be released after payment of fine has been made or imprisonment has been rendered.

b. An operator who violates the provision of Section 3 of this Ordinance shall pay a fine of Two Hundred Dollars (\$200.00) or imprisonment of ten (10) days or both upon the discretion of the court.

SECTION 10 - This Ordinance shall take effect after Ten (10) days of posting in at least two (2) conspicuous places in the Municipality.
