ORDINANCE NO. 23
Series of 1994

ORDINANCE PROHIBITING THE DUMPING OF GARBAGE AT ILOILO RIVER.

WHEREAS, Iloilo River is one of the sources of food and livelihood of residents beside the said river;

WHEREAS, it also serves as waterways during flood, outlet from ricefields and inlet to fish ponds beside its vicinity;

WHEREAS, its existence must be protected from garbage thrown by residents near it;

ON MOTION of Hon. Danilo E. Dalisay and duly seconded by Hon. Marvin L. Gison,

BE IT ORDAINED BY the Sangguniang Bayan of Oton in its Regular Session that:

SECTION 1 - DEFINITION OF TERMS:

- a. Garbage - anything worthless or filthy or other refuse such as ashes, used tin cans, papers, spoiled foods, etc.

SECTION 2 - PROHIBITED ACT.

- a. No person shall be allowed to dump garbage at the bank or side or into the Iloilo River.

SECTION 3 - PENALTY CLAUSE.

Any person or persons caught violating this Ordinance he/she be subject to the following penalties:

- 1) 1st Offense - A fine of P100.00 and/or 3 days imprisonment or both upon the discretion of the court;
- 2) 2nd Offense - A fine of P200.00 and/or 3 days imprisonment or both upon the discretion of the court;
- 3) 3rd Offense - A fine of P500.00 and/or 7 days imprisonment or both upon the discretion of the court;

SECTION 4 - EFFECTIVITY CLAUSE.

This Ordinance shall take effect after 5 days of posting at 2 conspicuous places.

SECTION 5 - Copies of this Ordinance shall be furnished to the Office of the Municipal Treasurer; Brgy. Pab. West; Brgy. San Antonio; Brgy. San Nicolas; Oton PNP; Municipal Trial Court; Mayor's Office, ~~and~~ the Sangguniang Panlalawigan of Iloilo for information and appropriate action. DENR, Regional Office for information.
