ORDINANCE CHANGING THE NAME OF CABOLOAN ELEMENTARY SCHOOL TO CAMBITW ELEMENTARY SCHOOL.

WHEREAS, the Local School Board forwarded to the Committee on Education of the Sangguniang Bayan of Oton a Resolution Requesting for a Change of Name of Caboloan Elementary School to CAMBITW Elementary School;

WHEREAS, upon the request for the change of name of Caboloan Elementary School to CAMBITW Elementary School, the Local Sanggunian consulted the National Historical Institute a procedure to be complied with under Art. 22 of the Implementing Rules of RA 7460, to wit: "...the Sanggunian of component cities and municipalities may in consultation with the National Historical Institute, change the name of the following within their respective territorial jurisdiction";

WHEREAS, the said request has conformed to the guidelines and limitations as provided for in Art. 23 of the Implementing Rules and Regulations of the Local Government Code of RA 7460, which are as follows:

1. The proposed name is not a living person.
2. It is justified, RE: Prayer of the Local School Board Resolution.
3. There was no change of name for the last Ten (10) years.
4. It has been recommended by the Local School Board.

Now therefore as proposed by the Committee on Education, on motion of Hon. Rene S. Escanlar and unanimously seconded, be it

ORDAINED by the Sangguniang Bayan of Oton in its Regular Session that:

SECTION 4 - Upon receipt of the recommendation of the National Historical Institute, both names shall be accommodated on the condition that the old name shall be placed beneath the new name as follows:

CAMBITW ELEMENTARY SCHOOL  
(Caboloan Elementary School)

**SECTION 2 - PURPOSE OF THE ORDINANCE.**

- a. The name of the Seven (7) barangays shall be combined, thus changing Cabolean Elementary School to CAMBITW Elementary School, giving credit and recognition to the said barangays.
- b. The old name shall be placed beneath the new name for the weighty reason that it will facilitate the delivery of postal matters and will serve as solid guide for people accustomed to the old name of the school.

**SECTION 3 - EFFECTIVITY CLAUSE.**

This Ordinance shall take effect Fifteen (15) days upon approval.
