ORDINANCE NO. 37
(Zoning Ordinance)
of 1995

AN ORDINANCE ADOPTING THE REVISED ZONING REGULATIONS FOR THE MUNICIPALITY OF OTON AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT THEREOF AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT THEREWITH.

Be it enacted by the Sangguniang Bayan of Oton:

WHEREAS, said Comprehensive Development Plan, which sets the development goals, objectives and priorities for the municipality within 1995-2005 planning time frame has been officially adopted by the Sangguniang Bayan by virtue of SB Resolution No. 14 dated February 24, 1995 and approved by the Sangguniang Panlalawigan of the Province of Iloilo during its regular session on May 31, 1995;

WHEREAS, the implementation of the Comprehensive Development Plan would require the enactment of regulatory measures to translate its development goals, objectives and priorities into reality;

WHEREAS, a zoning ordinance is one such regulatory measure which is an important tool for the implementation of the Comprehensive Development Plan;

NOW THEREFORE, the Sangguniang Bayan of Oton in a session assembled hereby adopts this Comprehensive Zoning Ordinance of the Municipality of Oton.

ARTICLE 1
TITLE OF THE ORDINANCE

SECTION 1. TITLE OF THE ORDINANCE - This Ordinance shall be known as the Comprehensive Zoning Ordinance with the community's comprehensive development plan.
