ORDINANCE NO. 2000 - 76

ORDINANCE ENACTING A POLICY FOR PORTRAITS AND PICTURES OF LOCAL CHIEF EXECUTIVES AND OTHER ELECTIVE MUNICIPAL OFFICIALS OF OTON, RESPECTIVELY.

AS PROPOSED by Hon. Jose Neil P. Olivares and Hon. Felimon Gregorio M. Calvo, on motion of the Committee on Tourism, Culture, Arts and History Hon. Jose Neil P. Olivares, Hon. Francisca C. Espeleta and Hon. Jose F. Tispon III and duly recorded by Hon. Mary Jean G. de los Santos

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo that:

SECTION I - DECLARATION OF POLICY

- It shall be the policy of this Local Government Unit that Local Chief Executives shall cause the display of their portraits in the Sangguniang Bayan Session Hall during their tenure of office.
- It shall likewise be the policy of this Local Government Unit that other elective municipal officials shall cause the display of their group pictures in the Municipal Library and Historical Center during their tenure of office.

SECTION II - DEFINITION OF TERMS.

For purposes of this ordinance, the following terms are hereby defined, to wit:

- Other Elective Municipal Officials** - refers to vice mayors and regular members of the Sangguniang Bayan duly elected in a regular election provided by law, and ex-officio members of the Sangguniang Bayan referring to the president of the Liga ng mga Barangay, the president of the Municipal Federation of the Sangguniang Kabataan, and such other elective positions as may be created or provided for by law.
- Portraits** - refer to the drawing in brown Sepia, 11x 15 inches with frames of the faces of the Local Chief Executives of Oton.
- Pictures** - refers to bond paper sized colored group pictures with frames of other elective municipal officials.

SECTION III - ADMINISTRATIVE PROVISION.

Portraits and pictures of Local Chief Executives and other municipal officials, respectively, shall be properly labeled, providing therein the names and term of office or tenure of office, as the case may be, by the General Services Officer.

SECTION IV - EFFECTIVITY.

This ordinance shall be effective upon its approval.
