**ORDINANCE NO. 2001 - 100**

**AN ORDINANCE DECLARING MABINI ST., OTON, ILOILO AS A ONE - WAY STREET FROM NOVEMBER 26 TO DECEMBER 1, 2001 AND EFFECTING ITS TEMPORARY CLOSURE FROM DECEMBER 2 - 9, 2001 IN CONNECTION WITH THE CELEBRATION OF THE MUNICIPAL AND RELIGIOUS FIESTA.**

ON MOTION of the Committee on Public Facilities and Utilities, namely: Hon. Simplicio R. Carreon, Jr., Hon. Victoriano P. Burgos and Hon. Edgar N. Javelana and unanimously seconded:

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:

**SECTION 1. INTRODUCTION.**

The yearly celebration of the Municipal and Religious Fiesta will be meaningful with the presence of "Ferias" that symbolizes real Filipino culture wherein Mabini Street traversing J.C. Zulueta St. and Claro M. Recto St. is the only site to be occupied by the operators of "Ferias" during the celebration.

**SECTION 2.** Rule VIII, Article 43 of the Implementing Rules and Regulations (IRR) of RA 7160 states that, "an LGU may through an Ordinance permanently or temporarily close or open any road, alley, park or square within its jurisdiction."

**SECTION 3.** Rule VIII, Article 45 of IRR of RA 7160 states that "(a) any national or local road, alley, park or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs or undertaking of public works and highways, telecommunication and water work projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order, as follows:

(Ord. No. 2001 100)

During Fiesta Celebration - for a period not exceeding nine (9) days."

**SECTION 4.** Rule VIII, Article 45 of IRR of RA 7160 states that "(b) any LGU may temporarily close and regulate the use of any local street, road or thoroughfare or public place where shopping malls, Sunday markets, flea or night markets or shopping area may be established and where goods, merchandise, foodstuff, commodities or articles of commerce may be sold and dispensed to the general public.

**SECTION 5. PROHIBITED AND REGULATED ACTS.**

1. All motor vehicles, both public and private passing Mabini St. shall temporarily pass Rizal St. extension or any accessible or convenient route.
2. There shall be installed traffic signs for the information of everybody.

**SECTION 6. EXCEPTIONS.**

Only trisikad may pass Mabini Street during daytime except on December 7 - 8, 2001

**SECTION 7. EFFECTIVITY.**

This shall take effect **November 26 to December 1, 2001** as a **One-Way Street**, and on **December 2 - 9, 2001**, it shall be **Temporarily Closed**


