ORDINANCE NO. 2001 - 101

AN ORDINANCE ENACTING THE 2001 MUNICIPAL REVENUE CODE OF THE MUNICIPALITY OF OTON, PROVINCE OF ILOILO.

ON MOTION of the Committee on Ways and Means, namely, Hon. Simplicio R. Carreon, Jr., Hon. Edgar N. Javellana and Hon. Victoriano P. Burgos and duly seconded by Hon. _____

BE IT ENACTED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance to wit:

ARTICLE A: SHORT TITLE AND SCOPE

SECTION 1A.01 - TITLE - This Ordinance shall be known as the 2001 Municipal Revenue Code of the Municipality of Oton, Province of Iloilo.

Copies of this Ordinance shall be furnished to the Municipal and Provincial Treasurer, Department of Finance, Manila, thru the Regional Office, Region 6, Iloilo City and the Sangguniang Panlalawigan, Province of Iloilo for appropriate action.
