ORDINANCE NO. 2001 - 94

AN ORDINANCE TEMPORARILY CLOSING BENEDICTO ST., OTON, ILOILO IN CONNECTION WITH THE ADDITIONAL WORK FOR THE IMPROVEMENT / CONCRETING OF THE SAME.

ON MOTION of the Committee on Legal Affairs, namely, Hon. Jafet P. Salinas, Hon. Edgar N. Javellana and Hon. Honorato P. Nad and duly seconded by Hon. Vicente B. Flores, Jr.


BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance to wit:

- SECTION 1. INTRODUCTION.**
The mandate of the government from the state is to promote the welfare of the people, and one of those is the improvement of the infrastructures.
- SECTION 2.** Rule VIII Article 43 of the Implementing Rules and Regulations (IRR) of RA 7160 that a Local Government Unit may through an Ordinance permanently or temporarily close or open any road, alley, park or square within its jurisdiction.
- SECTION 3.** Rule VIII, Article 45 of the IRR of RA 7160 states that "(a) any National or Local road, alley, park or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs or undertaking of public works and highways, telecommunications and water works projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order as follows:
1. Undertaking of Public Works and Highways (until the completion of the project including the curing period)
- SECTION 4. PROHIBITED AND REGULATED ACTS.**
1. All motor vehicles including triskad both private and public passing Benedicto St., Oton shall pass to any accessible or convenient route.
 2. There shall be installed traffic signs for the information of everybody.
- SECTION 5. EFFECTIVITY.**
This Ordinance shall take effect upon approval.

Copies of this Ordinance be furnished to the Office of the Mayor, MPDC, MEO, PNP, ABC, and the Sangguniang Pansalawigan of Iloilo for information and guidance.
