ORDINANCE NO. 2001 - 97

**AN ORDINANCE AMENDING CERTAIN
ARTICLES AND SECTIONS IN ORDINANCE
NO. 75, SERIES OF 2000.**

AS PROPOSED by Hon. Pablo S. Guevara, Jr., on motion of the Committee on Public Facilities and Utilities, namely: Hon. Simplicio R. Carrcon, Jr., Hon. Victoriano P. Burgos and Hon. Edgar N. Javellana and duly seconded by Hon. Felimon Gregorio M. Calvo

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:

SECTION 1. Amending Paragraph 1, Section 1 of Article I.

1. School Zones - are zones in the Municipality of Oton which is One Hundred (100) meters before and after the main gate of the frontage of Elementary and Secondary school's main building.

SECTION 2. Amending the Title of Article III.

Regulating the speed of motor vehicles within the Municipality of Oton and requiring drivers of all vehicles to stop during the playing / singing of "Pambansang Awit" along their route except on emergency cases.

SECTION 3. Amending Section 1 of Article III.

Drivers of all vehicles are required to regulate their speed limit not to exceed fifty (50) kilometers per hour while passing along the National Highway from boundary of Tigbauan - Oton (Cabanbanan) up to Anhawan Bridge and vice versa and from Batiano Bridge up to the boundary Oton - Iloilo City (Mohan) and vice versa except on emergency cases.

SECTION 4. Amending Section 2 of Article III.

Drivers of all vehicles are required to regulate their speed limit not to exceed thirty (30) kilometers per hour upon entering and passing the different school zones within the Municipality of Oton and within the Poblacion area except on emergency cases.

SECTION 5. Amending Section 3 of Article III.

Drivers are required to stop their motor vehicles and triskad during the playing / singing of "Pambansang Awit" along their route except on emergency cases.

SECTION 6. Amending Section 4, Article III.

Penalties. A violator thereof shall be meted a fine of Three Hundred Pesos (P300.00) or an imprisonment of three (3) days or both at the discretion of the Court

SECTION 7. Amending Paragraph (g), Section 1, Article V.

g. The area fronting Crown Agricultural Supply which is three (3) meters away from the leftmost portion of the said establishment near the Driver's Inn.

SECTION 8. Amending Paragraph (f), Section 3 of Article V

Handwritten signatures and initials on the left margin.

- f. Only five (5) tricycle units and one (1) public utility jeepney are allowed to park along Bonifacio St., beside the De los Santos Coffee Shop at a time and shall be succeeded by the next five (5) tricycle units and a public utility jeepney once they leave the said area. These tricycle units should park at least Ten (10) meters away from the backside (northeastern portion) of the waiting shed.

SECTION 9. Amending Section 2 of Article VI.

The front area of Oton Public Market from Christian Store up to Lydia Store is hereby declared as unloading area of private and delivery vehicles from 1:00 PM to 4:00 PM daily and unloading / loading area for public utility jeepneys and no parking for tricycle for hire.

SECTION 10. Amending Section 1, Article VIII

It is hereby declared that J.P. Laurel St. and Paterno St., as one way road from 6:00 AM to 8:00 AM; from 11:30 AM to 1:00 PM and from 5:00 PM to 6:00 PM, during class days.

SECTION 11. Amending Section 2, Article VIII.

All motor vehicles and tricycles coming from Brgy. Pob. West going to Brgy. Pob. North, Oton National High School and Brgy. Alegre are required to pass the road fronting the Church's main entrance going towards the road fronting Oton Central Elementary School and towards J.P. Laurel St. except during Saturday and Sunday and when there is Mass for the dead (Misa Requiem). Trisikad coming from Brgy. Poblacion West may pass and unload their passengers up to Batiano Bridge only and must not cross the main highway located on that bridge.

SECTION 12. Amending several paragraphs of Section I, Article IX.

e. Beside the Municipal Building fronting the Offices of the Municipal Treasurer, Post Office, COMELEC and Budget.

w. dirty or unreadable plate numbers

x. defective or no speedometer

y. defective headlight(s), stoplight(s), and / or signal lights

z. defective or no horn

aa. defective or no muffler

bb. no light(s), stoplight(s), and / or signal light(s)

cc. damaged and / or no windshield except when under repair

dd. wrong placement of plate number

cc. no upper chain cover

ff. truck(s) loaded with sand and gravel without cover (trapal)

SECTION 13. Amending Section 2, Article IX

Penalties. Violators hereof shall be meted a fine in the amount of One Hundred Pesos (P100.00) and one (1) day seminar or an imprisonment of three (3) days or both at the discretion of the court.

SECTION 14. Amending Paragraph c and d, Section 1, Article X.

c. Failure to show or surrender driver's license for cause or arrogance upon due demand by person with authority.

d. Driving recklessly in thickly populated areas disregarding the danger of accident

e. Trip cutting

SECTION 15. Amending Section 2, Article X

Penalties. Violators hereof shall be meted a fine of P300.00 and one (1) day seminar or an imprisonment of three (3) days or both at the discretion of the court

SECTION 16. Amending Section 1, Article XII

The Municipality of Oton Traffic Management Coordinating Committee

A body to be known as the Municipality of Oton Traffic Management Coordinating Committee, hereinafter referred to as the Committee, is hereby created which shall be composed of twelve (12) members, including the Chairman and Vice Chairman who shall be designated by the Honorable Mayor from among the members. Membership of the Committee shall consist of six (6) persons selected by the Mayor from the private sectors and six ex-officio members, namely:

1. SB Member, Chairman of the Committee on Public Facilities and Utilities
2. Representative from the Committee on Peace and Order and Public Safety
3. Chief of Police PNP Oton
4. Police In charge of Traffic
5. Municipal Engineer
6. Municipal General Services Officer

SECTION 17. This Ordinance shall take effect ten (10) days after approval and posting in at least two (2) conspicuous places in the Municipality

SECTION 18. This Ordinance shall be furnished to the Office of the Mayor, LTO, LTFRB; Oton PNP; DILG; MTC; MPDC; ABC; ODA, SAJODA; Tricycle and Trisikad Associations of Oton; other officers concerned and the Sangguniang Panlalawigan of Iloilo for information and guidance.
