ORDINANCE NO. 2003 - 109

AN ORDINANCE AMENDING CERTAIN ARTICLES AND SECTIONS OF THE MUNICIPAL ORDINANCE NO. 2000 - 75 (MUNICIPAL ORDINANCE ENACTING A TRAFFIC CODE IN THE MUNICIPALITY OF OTON, PROVINCE OF ILOILO AND PROVIDING PENALTIES FOR VIOLATION THEREOF) AND MUNICIPAL ORDINANCE NO. 2001 - 97 (AN ORDINANCE AMENDING CERTAIN ARTICLES AND SECTIONS IN ORDINANCE NO. 75, SERIES OF 2000).

AS PROPOSED by Hon. Pablo S. Guevara, Jr. on motion of the Committee on Public Utilities, namely: Hon. Simplicio R. Carraon, Jr., Hon. Victoriano P. Burgos and Hon. Edgar M. Javelana and duly seconded by Hon. Jafet P. Salinas and Hon. Eusebio G. Villavicencio

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:

- SECTION 1. AMENDING SECTION 11 OF ORDINANCE NO. 2001 - 97.**
 All tricycles coming from Poblacion West going to Poblacion North, Oton National High School and Brgy. Alegre, Oton must pass Mabini St., going to Rizal St., Oton fronting Oton Municipal Hall. Triskad coming from Brgy. Poblacion West may pass and must unload their passenger(s) up to Batiano Bridge only and must not cross the main highway along the bridge.
- SECTION 2. AMENDING PARAGRAPH C, SECTION 14 OF ORDINANCE NO. 2001 - 97.**
 Any person and / or driver apprehended by persons in authority, traffic aide and / or agent deputized by the Land Transportation Office (LTO), after the former's violation(s) was properly explained to him and when the apprehending officer demands to show and / or surrender his Driver's License, that person and / or driver show uncooperativeness, arrogance and threaten not to show and surrender his Driver's License to the said apprehending officer except on emergency case(s).
- SECTION 3.** Violation(s) of Section 2 of this Ordinance shall be meted a fine of P300.00 and one (1) day seminar or an imprisonment of three (3) days or both at the discretion of the court.
- SECTION 4. AMENDING PARAGRAPH I, SECTION 1 OF ARTICLE X OF ORDINANCE 2000 - 75.**
 Any driver of Public Utility Jeepney(s) in the Municipality of Oton that pick - up passengers outside of specific route as embodied in his Certificate of conveyance / Franchise to Operate issued by the LTFRB and without specific / special permit from the LTO to go to such destination except those PUJs which ply along the National Highway of the Southern towns of Iloilo except on emergency cases.
- SECTION 5.** Violation(s) of Section 4 of this Ordinance shall be meted a fine of P600.00 and one (1) day Seminar or an imprisonment of three (3) days or both at the discretion of the court.
- SECTION 6.** This Ordinance shall take effect ten (10) days after approval and posting in at least two (2) conspicuous places in the Municipality.
- SECTION 7.** Copy of this Ordinance shall be furnished to the Office of the Mayor; LTO; LTFRB; Oton PNP; DILG; MTC; MPDC; ABC; JODAI; SOJODA; Tricycles and Triskads Associations of Oton; MTO; MBO; Acctg. Office; other Offices concern and the Sangguniang Panlalawigan of Iloilo for information and guidance.
