**ORDINANCE NO. 2003 - 120**

**AN ORDINANCE DECLARING BONIFACIO, PORTION OF CLARO M. RECTO, MABINI, F.C. ZULUETA, GENERAL LUNA, RIZAL, AND PORTION OF J.C. ZULUETA STREETS, OTON, ILOILO TEMPORARILY CLOSED ON APRIL 28, 2004 FROM 2:00 PM TO 6:30 PM AND ON MAY 3, 2004 FROM 1:00 PM TO 7:30 PM IN CONNECTION WITH THE CELEBRATION OF THE 432ND FOUNDATION ANNIVERSARY OF OTON.**

**ON MOTION** of the Committee on Peace and Order / Public Safety, namely: Hon. Pablo S. Guevara, Jr., Hon. Simplicio R. Carreon, Jr. and Hon. Edgar N. Javellana and duly seconded by Hon. Felimon Gregorio M. Calvo

**BE IT ORDAINED** by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:

- SECTION 1. INTRODUCTION.** The celebration of the 432nd Foundation Day of this Municipality will be highlighted by various activities especially "Tribal Contest" of compelling tribes from the different barangays of Oton.
- SECTION 2.** Rule VIII, Article 45 of the Implementing Rules and Regulations (IRR) of RA 7160 states that, "an LGU may through an Ordinance permanently and temporarily close or open any road, alley, park or square within its jurisdiction."
- SECTION 3.** Rule VIII, Article 45 of IRR of RA 7160 states that "(a) any national or local road, alley, park or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs or undertaking of public works and highways, telecommunication and waterwork projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order, as follows:
- SECTION 4.** Rule VIII, Article 45 of IRR of RA 7160 states that "(b) any LGU may temporarily close and regulate the use of any local street, road or thoroughfare or public place where shopping malls, Sunday Markets, flea or night markets or shopping area may be established and where goods, merchandise, foodstuff, commodities or articles of commerce may be sold and dispensed to the general public."
- SECTION 5. PROHIBITED AND REGULATED ACTS.**
- Southern and Northern bound private and public vehicles shall pass through Diversion Road, Oton, San Jose Road, Claro M. Recto, Burgos and J. C. Zulueta Streets.
  - There shall be PNP (Traffic Aide) to man the area for direction and rerouting of all passing vehicles.
- SECTION 6.** This shall take effect on April 28, 2004 and on May 3, 2004 as Temporarily Closed.
- SECTION 7.** Copies of this Ordinance shall be furnished to the Office of the Mayor; Oton PNP, ABC, GSO, MPDC and the Sangguniang Pankalawigan of Iloilo for information and guidance.
