ORDINANCE NO. 2004 - 122

AN ORDINANCE IMPOSING FEES TO ALL TRICYCLE / TRISIKAD FOR HIRE OPERATING IN THE MUNICIPALITY OF OTON, ILOILO REQUESTING FOR A COPY OF A TARIFF AUTHORIZING FARE INCREASE FROM THE OTON MUNICIPAL FRANCHISING REGULATORY BOARD (OMFRB) AND REGULATING ITS PERIOD OF ISSUANCE.

AS PROPOSED by Hon. Edgar N. Javellana, on motion of the Committee on Public Utilities and Facilities, namely, Hon. Simplicio R. Carreon, Jr., Hon. Victoriano P. Burgos and Hon. Edgar N. Javellana and duly seconded by Hon. Eusebio G. Villavicencio, Jr. and Hon. Vicente B. Flores, Jr.

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance to wit:

SECTION 1. INTRODUCTION. The Oton Municipal Franchising Regulatory Board (OMFRB) was created by virtue of Resolution No. 54-1992 to plan and implement Tricycles -for-hire (MCH) and Trisikad franchise and operations / regulations in the Municipality of Oton.

Pursuant to Title II, Section 447, Par. 3 and Sub. Par. VI, Resolution No. 54 - 1992 was amended by Resolution 115-2000 to include among the functions of the OMFRB, the regulation of tariff rates of MCH and Trisikads upon petition or request of any MCH or Trisikad association taking into consideration the prevailing oil prices, the wear and tear of vehicles of different routes

Due to the recent oil price hike, seven (7) MCH Associations in Oton petitioned the Office of the Mayor and the Sangguniang Bayan of Oton for fare rate increase. Acting on this request, the OMFRB convened last June 15, 2004 to establish the fare rate increase taking into consideration the twenty percent (20%) discount of students, disabled persons and senior citizens. The said tariff rate will be effective after determination of landmarks from which to measure rate increase per kilometer (kilometraje) of the respective associations. In addition, the Board also agreed to impose corresponding fees to MCH and Trisikad operators for incidental expenses incurred in the issuance of an approved Tariff Rate and providing a reglementary period for its issuance in accordance with the above-cited provision.

SECTION 2. DEFINITION OF TERMS.

- 1) **Board** - refers to OMFRB
- 2) **Tariff** - approved fare rate
- 3) **Fees** - refers to payment for incidental expenses for issuance of the Tariff rate by the Treasurer's Office.

SECTION 3. FEES.

- 1) Fees for issuance of Tariff to MCH operators is Fifty Pesos (P 50.00)
- 2) Fess for issuance of Tariff to Trisikad operators is Thirty Pesos (P 30.00)
- 3) Deadline for issuance of Tariff shall be on July 30, 2004.

SECTION 4. PENALTY.

- 1) MCH and Trisikad operators caught violating the present Tariff by overcharging passenger(s) shall be penalized by a Fine of Two Hundred Pesos (P200.00).
- 2) Operators who failed to secure a Tariff by July 30, 2004 shall be charged One Hundred Fifty Pesos (P150.00) for its issuance. The OMFRB reserves the right to cancel / revoke or amend existing Tariff upon cessation of its factual basis.

SECTION 5. EFFECTIVITY This Ordinance shall be made effective upon approval.

SECTION 6. Copies of this Ordinance shall be furnished to the Oton PNP Station, MCH and Trisikad Associations; the Municipal Treasurer's Office, Office of the Mayor of Oton and the Sangguniang Panlalawigan of Iloilo for information and guidance.
