ORDINANCE NO. 2004 - 132

AN ORDINANCE REGULATING AND PRESCRIBING SPECIFIC ROUTES IN THE POBLACION AREA OF TRICYCLES - FOR - HIRE PLYING ALONG BURAY AND SAN JOSE ROAD, OTON, ILOILO.

ON MOTION of the Committee on Public Facilities and Utilities, namely, Hon. Simplicio R. Carreon, Jr., Hon. Edgar N. Javellana and Hon. Eusebio G. Villavicencio, Jr. and duly seconded by Hon. Jose Neil P. Olivares and Hon. Francisca C. Ezpeleta

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:

- SECTION 1. INTRODUCTION.** Last September 6, 2004 the Committee on Public Facilities and Utilities conducted a Committee Meeting to discuss among others the heavy concentration of traffic on C.M. Recto Street, this Municipality. As a result of this meeting, the committee called for a public consultation last September 9, 2004 with MCH Drivers and Operators to discuss this issue which also included a proposed route for tricycles during funeral procession.
- In view of the foregoing, the committee concerned invokes Section 447, Par. 3 (vi) which empowers the Sangguniang Bayan to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality to address the said problem. It is the desire of the Sanggunian to decongest traffic in C.M. Recto St. to promote the general welfare of its inhabitants.
- SECTION 2. New route of tricycles plying along the San Jose Road, Oton, Iloilo.** MCHs or tricycles plying along the San Jose Road (Tagbac Norte & Sur, Mambog, Abilay Norte, Bitá Sur and Tuburan) shall pass C.M. Recto Street from their point of origin going to the town proper terminal. MCHs plying said route returning from the Poblacion to convey passengers in their areas of operation shall pass through F.C. Zulueta Street, turn right to General Luna before proceeding to San Jose Road.
- SECTION 3. New route for tricycles plying Buray - Sta. Rita - Sta. Monica, Galang, Cadinglian, Baras and Salangan, Oton, Iloilo.** MCHs or tricycles plying along Buray - Sta. Rita - Sta. Monica, Galang and Cadinglian route shall pass C.M. Recto Street from their point of origin whether Buray, Sta. Rita, Galang, Salangan, Cadinglian, Baras and Sta. Monica going to the town proper terminal. MCHs plying said route returning from the Poblacion to convey passengers in their areas of operation shall pass through Rizal Street turning right to Burgos Street.
- SECTION 4. MCH route during Funeral Procession.** In case of funeral procession, MCHs plying Buray - Sta. Rita - Sta. Monica, Galang, Cadinglian, Baras and Salangan route may pass C.M. Recto Street.
- SECTION 5. PENALTY CLAUSE.** Violators hereof shall be meted a fine in the amount of One Hundred Pesos (P100.00) and / or imprisonment of one (1) day or both at the discretion of the court.
- SECTION 6. REPEALING CLAUSE.** All other ordinances, order, rules and regulations or parts thereof which are inconsistent with any provision of this Ordinance, are hereby deemed repealed or modified accordingly.
- SECTION 7. EFFECTIVITY CLAUSE.** This Ordinance shall take effect after approval and ten (10) days of posting in at least two (2) conspicuous places in the Municipality.
- SECTION 8. COPIES.** This Ordinance shall be furnished to the Office of the Mayor; PNP - Oton; MTO; MTC; MCH Assns.; Poblacion West; and the Sangguniang Pambalawigan of Iloilo for information and guidance.
