ORDINANCE NO. 2004 – 137

AN ORDINANCE AMENDING SEVERAL PROVISIONS OF MUNICIPAL ORDINANCE NO. 2000 – 75, AN ORDINANCE ENACTING A TRAFFIC CODE OF THE MUNICIPALITY OF OTON, PROVINCE OF ILOILO AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

ON MOTION of the Committee on Peace and Order, namely: Hon. Pablo S. Guevara, Jr., Hon. Jose Neil P. Olivares and Hon. Edgar N. Javellana and duly seconded by Hon. Virginia F. Olivares

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:


- SECTION 1.** Amending Par. i of Section 1, Article X of Municipal Ordinance No. 2000 – 75.
i. No/expired Official Receipt and or Certificate of Registration.
- SECTION 2.** Amending Section 2, Article 10 of Municipal Ordinance No. 2000 – 75.
Penalties. Violator(s) hereof shall be meted a fine of Two Hundred Fifty Pesos (P250.00) or an imprisonment of three (3) days or both at the discretion of the court.
- SECTION 3.** Amending Section 4 of Municipal Ordinance No. 2003 – 109
Outside Route – Any driver of Public Utility Jeepney(s) in the Municipality of Oton and other places that convey and pick – up passengers outside of specific route as embodied in his / her Certificate of Conveyance / Franchise – To – Operate issued by the LTFRB and without specific / special permit from the LTO to go to such destination except those PUJs which play along the National Highway of the Southern Towns of Iloilo except on emergency cases.
- SECTION 4.** Amending Section 5 of Ordinance No. 2003 – 109 – Violation(s) of Section of this Ordinance shall be meted a fine of P800.00 and one (1) day Seminar and / or imprisonment of three (3) days at the discretion of the court.
- SECTION 5.** This Ordinance shall take effect after 3 weeks following the completion of their posting in 2 conspicuous places in the municipality and publication in a Local Journal.
- SECTION 6.** This Ordinance shall be furnished to the Office of the Mayor; LTO; LTFRB; Oton – PNP; DILG; MTC; MPDO; ABC; JODAI; SOJODA and Tricycle Associations of Oton; other offices concerned and the Sangguniang Panlalawigan of Iloilo for information and guidance.


