ORDINANCE NO. 2004 – 138

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 32, SERIES OF 1994 AND SECTIONS 1 AND 3 OF ORDINANCE NO. 41, SERIES OF 1996.

ON MOTION of the Committee on Public Facilities and Utilities, namely, Hon. Simplicio R. Carreon, Jr., Hon. Edgar N. Javellana and Hon. Eusebio G. Villavicencio, Jr. and duly seconded by Hon. Francisca C. Ezpeleta

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:

- SECTION 1.** To adopt specialization of MCH operation and a concentrated Public Utility Services, the following shall be the route of MCH with its corresponding color code which shall only be available for operation after the application of MTOP:
- Poblacion, Oton – Lambuyao – Abilay Sur / Norte – **Pulo Maestra Vita** and vice versa (**YELLOW**)
 - Poblacion, Oton – Tagbac Sur / Norte – **Tuburan** and vice versa (**GREEN**)
 - Poblacion, Oton – Bitas Sur – Mambog – **Abilay Norte** and vice versa (**MAROON**)
 - Poblacion, Oton – Sta. Rita – Galang – **Salangan** and vice versa (**FIRE RED**)
 - Poblacion, Oton – Sta. Rita – Sta. Monica – Rizal – **Sta. Clara** and vice versa (**LIGHT BLUE**)
 - Poblacion, Oton – Sta. Rita – Sta. Monica – Cadinglian – **Turog-turog** and vice versa (**CHERRY PINK**)
 - Poblacion, Oton – Buray via **FLORVEL** and vice versa (**NAVY BLUE**)
 - Poblacion, Oton – **Sitio Baras** and vice versa (**GRAY**)
 - Poblacion, Oton (N S E W)** and vice versa (**BROWN**)
 - Poblacion, Oton – **Alegre** and vice versa (**YELLOW GREEN**)
 - Poblacion, Oton – **Calam-isán** and vice versa (**WHITE**)
 - Crossing Botong – Sambaludan – Batuan Ilaud / Ilaya – Cadinglian – **Turog-turog** and vice versa (**ORANGE**)
 - Mohon – Cagbang – **Pakiad** and vice versa (**GOLD**)

SECTION 2. REGULATED ACTS.

- a. MCH unit identified thru color code shall be allowed only to operate in a route specified in Section 1 hereof except when hired for private use and during fiesta celebration.
- b. Operators shall be required to print the four (4) inches width panel route on their units at the front and side portion of every unit.
- c. The color coding scheme on every side car of each MCH unit shall be made by the operators as prescribed in this Ordinance.
- d. There shall be a renewal or amendment of Provisional Authority (PA) to operate as regards to the provisions on route, on which operators shall renew or amend the route of their units within one (1) month from the date of effectivity of this Ordinance.
- e. Drivers of MCH units are duty bound to transport passengers who are commuting along their line of operation / route although the barangay or sitio is not mentioned in the provision on route filed with OMFRB.

SECTION 3. EFFECTIVITY CLAUSE. This Ordinance shall take effect after 3 weeks following the completion of its posting in 2 conspicuous places in the municipality and publication in the Ogtonganon Newsletter.
