ORDINANCE NO. 2005 - 147

AN ORDINANCE TEMPORARILY CLOSING A PORTION OF CLARO M. RECTO STREET, PARTICULARLY AT THE BACK OF THE OTON AMPHITHEATRE GREEN EXCEPT THE INTERSECTIONS, FROM 5:00 PM TO 12:00 MIDNIGHT FROM DECEMBER 15 - 23, 2005 DURING THE LIGHT - A - TREE PROGRAM AND FOOD FESTIVAL.

ON MOTION of the Committees on Public Safety, namely, Hon. Pablo S. Guevara, Jr., Hon. Jose Neil P. Olivares and Hon. Edgar N. Javelana and Public Facilities and Utilities, namely, Hon. Simplicio R. Carreon, Jr., Hon. Edgar N. Javelana and Hon. Eusebio G. Villavicencio, Jr. and duly seconded by Hon. Jafet P. Salinas

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:

- SECTION 1. **INTRODUCTION.** The yearly celebration of the Christmas Season will be meaningful through the Light - A - Tree Program and Food Festival that gives meaning to the guiding light of Filipinos for a bountiful life in the future wherein a portion of Claro M. Recto Street at the back of the Oton Amphitheatre Green is the only site to be occupied by seller of food and drinks during the celebration.
- SECTION 2. Rule VIII, Article 43 of the Implementing Rules and Regulations (IRR) of RA 7160 states that, "an LGU may through an Ordinance permanently or temporarily close or open any road, alley, park or square within its jurisdiction."
- SECTION 3. Rule VIII, Article 45 of IRR of RA 7160 states that "(a) any national or local road, alley, park or square may be temporarily closed during actual emergency or festa celebrations, public rallies, agricultural or industrial fairs or undertaking of public works and highways, telecommunication and water work projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order, as follows: During Fiesta Celebration - for a period not exceeding nine (9) days."
- SECTION 4. Rule VIII, Article 45 of IRR of RA 7160 states that "(b) any LGU may temporarily close and regulate the use of any local street, road or thoroughfare or public place where shopping malls, Sunday markets, flea or night markets or shopping area may be established and where goods, merchandise, foodstuff, commodities or articles of commerce may be sold and dispensed to the general public.
- SECTION 5. **PROHIBITED AND REGULATED ACTS.**
 1. A portion of Claro M. Recto Street particularly at the back of the Amphitheatre Green shall be declared **Temporarily Closed** from 5:00 PM to 12:00 Midnight on **December 15 - 23, 2005.**
 2. All motor vehicles, both public and private passing the abovementioned portion of Claro M. Recto Street shall temporarily pass Rizal Street extension or any accessible or convenient route.
 3. There shall be installed traffic signs for the information of everybody.
- SECTION 6. **EXCEPTION.** All motor vehicles, both public and private may pass the abovementioned portion of Claro M. Recto Street during daytime from December 15 - 23, 2005 only.
- SECTION 7. **EFFECTIVITY.** This shall take effect upon approval.
- SECTION 8. **COPIES.** This Ordinance shall be furnished to the Office of the Mayor; Oton - PNP, MPDC; GSO; ABC and the Sangguniang Pantlalawigan of Iloilo for information and guidance.
