ORDINANCE NO. 2006 – 152

AN ORDINANCE AMENDING PARAGRAPH (H) SECTION 4 OF MUNICIPAL ORDINANCE NO. 2001 – 92.


ON MOTION of the Committee on Culture, History, Arts and Tourism, namely, Hon. Jose Neil P. Olivares, Hon. Eusebio G. Villavicencio, Jr. & Hon. Pablo S. Guevara, Jr. and duly seconded by Hon. Virginia F. Olivares

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:


- SECTION 1.** Paragraph (h), Section 4 of Ordinance No. 2001 – 92 shall be amended into:
- SECTION 2.** h. May 3 every year shall be the Foundation Day of the Municipality of Oton – the First Pueblo (Town) in Western Visayas. It shall otherwise be dubbed as the "Katagman Festival". The Local Chief Executive shall issue a Proclamation declaring this date as Special Day of observance in the entire Municipality. Relevant activities on culture, history and arts shall be done during or before this date. The festival shall be registered or affiliated with the Department of Tourism and the National Commission for Culture and the Arts (NCCA) or its agencies;
- SECTION 3.** **EFFECTIVITY.** This Ordinance shall take effect upon approval.
- SECTION 4.** **Copies.** This Ordinance shall be furnished to the Office of the Mayor; ABC; SK Municipal Federation; Department of Tourism; MCCA; and the Sangguniang Panlalawigan of Iloilo for information and guidance.
