BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, an Ordinance, to wit:

- SECTION 1. INTRODUCTION.** Municipal Ordinance No. 2006 – 168 otherwise known as “An Ordinance declaring Mabini Street, Oton, Iloilo as a One – Way Street from November 25 to December 6, 2006 and effecting its temporary closure from December 7 to 9, 2006 in connection with the celebration of the civic and religious fiesta” is hereby **REPEALED** considering that the purpose, intent and application of the said Ordinance are moot and academic already.
- SECTION 2.** This Ordinance shall take effect upon approval
- SECTION 3. COPIES.** This Ordinance shall be furnished to the Office of the Mayor for information and guidance.




