ORDINANCE NO. 2006 – 175

**AN ORDINANCE AMENDING SECTION 1 OF ARTICLE II OF
ORDINANCE NO. 06, SERIES OF 1991 KNOWN AS "AN
ORDINANCE REQUIRING ALL VENDORS TO USE THE
STALLS / SECTIONS ASSIGNED TO THEM IN THE PUBLIC MARKET".**

AS PROPOSED by Hon. Edgar N. Javellana, **on motion** of the Committee on Ways and Means, namely, Hon. Eusebio G. Villavicencio, Jr., Hon. Edgar N. Javellana and Hon. Francisca C. Ezpeleta and duly seconded by Hon. Jafet P. Salinas

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo:

SECTION 1. "ARTICLE II – PENALTIES."

SECTION 1. Persons caught violating this Ordinance shall pay a fine of P150.00 for the First Offense; P300.00 for the Second Offense; and P500.00 for the Third Offense or imprisonment of not less than one (1) day and not more than five (5) days or both at the discretion of the Court.


SECTION 2. REPEALING CLAUSE. All municipal ordinances or parts of any municipal ordinance inconsistent with provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 3. EFFECTIVITY CLAUSE. This Ordinance shall take effect after 3 weeks following the completion of its posting in at least 2 conspicuous places in the municipality and publication in the newsletter / journal of the Municipality of Oton.

SECTION 4. COPIES. This Ordinance shall be furnished to the Office of the Mayor; Public Market Vendors Association; Oton PNP; Admin; MTO; Acctg.; MTC; and the Sangguniang Panlalawigan of Iloilo for information and guidance.
