ORDINANCE NO. 2008 – 197

AN ORDINANCE AMENDING ORDINANCE NO. 2006 – 169 OTHERWISE KNOWN AS “AN ORDINANCE ENACTING THE MUNICIPAL TAX CODE OF THE MUNICIPALITY OF OTON OF YEAR 2007.”

ON MOTION of the Hon. Antonio Hadji C. Gepayo and duly seconded by Hon. Simplicio R. Carreon, Jr.

BE IT ENACTED by the Sangguniang Bayan of Oton, Iloilo, that:

- SECTION 1. **INTRODUCTION.** Based on the recommendation and request of the Municipal Treasurer’s Office and the Local Chief Executive, there is a need to amend some provisions of the abovementioned Tax Code since most of them are typographical in nature and impractical to implement.
- SECTION 2. The amendments are the following:
- a) One page 16 of the said Tax Code under subparagraph 7 (Subdivision owners, private cemeteries and memorial parks), P125.00 / sq. meter shall be amended into P1.25 / sq. meter;
 - b) Finance and Investment companies up to rural banks on page 20 of the same code shall be deleted;
 - c) On page 22, Section 2A.05. Tax on Newly Started Business shall only be one percent (1%) of the capital investment. One – twentieth shall be deleted.
- SECTION 3. **REPEALING CLAUSE.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
- SECTION 4. **SEPARABILITY CLAUSE.** If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.
- SECTION 5. **EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.
- SECTION 6. **COPIES.** This Ordinance shall be furnished to the Office of the Mayor; MTO; and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
