ORDINANCE NO. 2009 – 19 (220)

AN ORDINANCE AMENDING MUNICIPAL ORDINANCES NOS. 2009 – 09 AND 2009 – 06, FIXING THE ROUTE MEASURE CAPACITY OF MOTORCYCLE – FOR – HIRE (MCH) IN CAMBITODA AREA.

ON MOTION of the Committee on Public Facilities and Utilities, namely: Hon. Simplicio R. Carreon, Jr., Hon. Felix L. Flores and Hon. Margarito T. Clavel III and duly seconded by Hon. Cesar B. Digao

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. Introductory Clause. It has been an adopted policy that there shall be allotted at least one (1) unit of MCH to previous PUJ operators plying the route Poblacion, Oton to Bitar Sur, Mambog, Abilay Norte, Caboloan Sur, Bitar Norte, Caboloan Norte and vice versa under the service area of CAMBITODA.

SECTION 2. Amendatory Clause. Considering that there are still two (2) former PUJ owners who have not yet availed of the above allotment of MCH, Section 3 of Municipal Ordinance No. 2009 – 06 and Section 2 of Municipal Ordinance No. 2009 – 9 shall be amended into: "By virtue of the amendment above, considering that Barangays Caboloan Norte and Bitar Norte are now under the service area of CAMBITODA, the Total Route Measure capacity (RMC) of this route shall be fixed to sixty three (63) units.

SECTION 3. Effectivity Clause. This Ordinance shall take effect upon approval.

SECTION 4. Copies. This Ordinance shall be furnished to the Office of the Mayor; CAMBITODA; Federation of MCH Associations; and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
