ORDINANCE NO. 2009 - 6 (207)

AN ORDINANCE AMENDING SECTION 39I - 2C AND 39I - 2K OF MUNICIPAL ORDINANCE NO. 2007 - 182, OTHERWISE KNOWN AS THE CODE ON GENERAL ORDINANCES.

AS PROPOSED by Vice Mayor Jose Neil P. Olivares, **ON MOTION** of the Committee on Public Facilities and Utilities, namely: Hon. Simplicio R. Carmon, Jr., Hon. Felix L. Flores and Hon. Margarito T. Clavel III and duly seconded by Hon. Eusebio G. Villavicencio, Jr.

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. INTRODUCTION.

- a) There is a need to extend the MCH service of CAMBITODA (Caboloan, Abilay Norte, Mambog, Bita and Tuburan Operators and Drivers Association) to Barangays Caboloan Norte and Bita Norte since PUJs in this route ceased to operate. Acting on the request of the residents of Bita Norte through their Barangay Council, and on appeals of many constituents in that area, this Sanggunian sees the necessity of this Ordinance.
- b) The opening of Caboloan Sur - Caboloan Norte and Calam-isan - Saingan barangay roads serving as new farm-to-market roads necessitates the amendments contained herein.

SECTION 2. The following shall be the amendments

Section 39I - 2c. Poblacion, Oton - Bita Sur - Mambog - Abilay Norte - Caboloan Sur - Bita Norte - Caboloan Norte and vice versa (Maroon).

Section 39I - 2k. Poblacion, Oton - Calam-isan - Saingan and vice versa (White).

SECTION 3. By virtue of the amendment above, considering that Barangays Caboloan Norte and Bita Norte are now under the service area of CAMBITODA, an additional of ten (10) units of MCH shall be added to its original Route Measure Capacity (RMC) which is 50, thus totaling it to 60.

SECTION 4. This Ordinance shall take effect upon approval.

SECTION 5. COPIES. This Ordinance shall be furnished to the Office of the Mayor; MTO; OMFRB Records Officer; CAMBITODA; CATDOA; Federation of MCH Associations; Barangay Councils concerned; Oton PNP; and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.

UNANIMOUSLY APPROVED.
