ORDINANCE NO. 2010 - 04 (225)

AN ORDINANCE TEMPORARILY CLOSING FRANCISCO C. PLANTA STREET FROM 6:00AM OF MAY 16, 2010 TO 12:00 NOON OF MAY 18, 2010 ON THE OCCASION OF THE BARANGAY FIESTA AND MAYFLOWER FESTIVITY OF BRGY. POBLACION NORTH, OTON, ILOILO.

ON MOTION of Hon. Simplicio R. Carreon, Jr. and duly seconded by Hon. Virginia F. Olivares

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. Introduction. Francisco C. Planta Street, Oton, Iloilo is a short stretch of road connecting Paterno Street and JP Laurel Street this Municipality, fronting west side gate of Oton National High School (ONHS). In view of the forthcoming Barangay Fiesta and Mayflower festivity of Poblacion North, this stretch of road shall be utilized as venue of programs and other activities.

SECTION 2. Temporary Closure of Francisco C. Planta Street. Pursuant to Section 21 (c) of R.A. 7160, the Local Government Code of 1991, Francisco C. Planta Street is declared temporarily closed in order to provide venue for the programs and other activities in relation to the Barangay Fiesta and Mayflower Festivity of Poblacion North from 6:00 AM of May 16 to 12:00 Noon of May 18, 2010.

SECTION 3. Temporary Rerouting of Vehicles. In connection with the foregoing provision, all vehicles, public and private, including tricycles and Trisikads are hereby prohibited to:

1. Utilize F. C. Planta Street in going to ONHS and Brgy. Alegre via J.P. Laurel Street. These vehicles shall be temporarily rerouted to J.P. Laurel Street, corner of Lopez Jaena Street and Batiano Bridge; and
2. Utilize F. C. Planta in going to Brgy. Poblacion East, and other points of destination via Paterno Street, from 6:00 AM of May 16 to 12:00 Noon of May 18, 2010

SECTION 4. Public Information and Guidance. In order to guide the public, there shall be installed:

1. Signages or billboards of temporary nature and materials which shall be provided by the Barangay Officials concerned informing the commuters of the temporary closure of F. C. Planta Street from 6:00 AM of May 16 to 12:00 Noon of May 18, 2010.
2. There shall be Barangay Tanods assigned in the corner of Lopez Jaena Street and J. P. Laurel Street and Lopez Jaena Street and Paterno Street to help in the traffic management and implementation of this Ordinance.

SECTION 5. Effectivity. This Ordinance shall take effect from May 16 to May 18, 2010.

SECTION 6. Copies. This Ordinance shall be furnished to the Office of the Mayor; Oton PNP; Barangay Poblacion North, and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
