ORDINANCE NO. 2010 – 07 (228)

AN ORDINANCE DECLARING MABINI STREET AS A ONE – WAY STREET FROM NOVEMBER 26 TO DECEMBER 6, 2010 AND EFFECTING ITS TEMPORARY CLOSURE FROM DECEMBER 7 TO 9, 2010 AND BONIFACIO STREET AS A ONE – WAY STREET ON DECEMBER 4, 2010.

ON MOTION of Hon. Juan Miguel M. Flores and duly seconded by Hon. Michelle G. Babiera

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. INTRODUCTION. Mabini Street connects J. C. Zulueta Street to C. M. Recto Street on the Poblacion traversing West side of Oton Amphitheatre Green. In view of the annual Patronal Fiesta of Oton, this stretch of road shall be used for games and amusements, comprising the Feria.

SECTION 2. TEMPORARY CLOSURE OF MABINI STREET. Pursuant to Section 21 (a) of R. A. 7160, the Local Government Code of 1991, Mabini Street is declared as a one-way street from November 26 – December 6, 2010 and shall be temporarily closed on December 7 – 9, 2010 in connection with Oton's Annual Patronal Fiesta.

SECTION 3. TEMPORARY REROUTING OF VEHICLES. In connection with the foregoing provision, all public utility vehicles and private cars or trucks, including tricycles, trisikads and motorbikes are hereby prohibited to utilize Mabini Street in going to J.C. Zulueta, Rizal, F. C. Zulueta and C.M. Recto Streets.

- 1) Vehicles from Barangays Caboloan Norte, Caboloan Sur, Bitar Norte and Bitar Sur, passing Mambog, Tuburan, Tagbac Norte and Tagbac Sur to the Poblacion, are temporarily rerouted to C. M. Recto and Bonifacio Streets.
- 2) Vehicles from Barangay Sta. Clara, passing Rizal, Sta. Monica, Sta. Rita and Buray to the Poblacion are temporarily rerouted to General Luna and J. C. Zulueta Streets.

SECTION 4. TEMPORARY CLOSURE OF BONIFACIO STREET. Bonifacio Street shall be declared as a one way street on December 4, 2010 from 5:30 AM to 9:00 AM in connection with the First Very Friendly Fun Run / Walk for a Cause.

SECTION 5. PUBLIC INFORMATION AND GUIDANCE. In order to guide the public, there shall be installed:

- 1) Signages or billboards of temporary nature informing the commuters of the temporary closure of Mabini and Bonifacio Streets as outlined in the preceding provision.
- 2) There shall be Traffic Aides and / or Barangay Tanods assigned at the junction of C. M. Recto and San Jose Road, corner of C.M. Recto and Mabini Streets, Rizal and Mabini Streets, J.C. Zulueta and Mabini Streets and Bonifacio Street (between the Plaza and Parish Church) to facilitate an orderly traffic management.

SECTION 6. This Ordinance shall take effect on November 26, 2010.

SECTION 7. COPIES. This Ordinance shall be furnished to the Office of the Mayor, GSO, Oton PNP, 4 Poblacion Barangays and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
