ORDINANCE NO. 2010 - 08 (229)

AN ORDINANCE DECLARING THE TEMPORARY CLOSURE OF HANNIL ROAD AT BARANGAY SAN ANTONIO, OTON, ILOILO FROM NOVEMBER 27 TO 28, 2010 IN CONNECTION WITH THE MEDALLA MILAGROSA PATRONAL FIESTA.

ON MOTION of Hon. Juan Miguel M. Flores and duly seconded by Hon. Serafin N. Clavel II
 BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. Introductory Clause. The residents and parishioners in Sitio Upa, San Antonio will be celebrating their Annual Religious Fiesta in honor of its Patron Saint Virgin of Medalla Milagrosa, thus will utilize the Hannil Road at Barangay San Antonio for the various fiesta activities.

SECTION 2. Temporary Closure of HANNIL Road, Brgy. San Antonio, Oton. Pursuant to Section 21 (c) of R.A. 7160, Hannil Road at Brgy. San Antonio, Oton shall be temporarily closed on November 27 at 8:00 AM to November 28, 2010 in connection with the Medalla Milagrosa Patronal Fiesta.

SECTION 3. Public Information and Guidance.

- In order to guide the public, there shall be installed a signage of temporary nature informing the commuters of the temporary closure of Hannil Road at Barangay San Antonio.
- There shall be traffic aides and / or Barangay Tanods assigned at the approaches of Hannil Road and San Jose Road to facilitate an orderly traffic management.

SECTION 4. Effectivity Clause This Ordinance shall take affect on November 27, 2010.

SECTION 5. Copies. This Ordinance shall be furnished to the Office of the Mayor; Barangay San Antonio and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
