**ORDINANCE NO. 2011 – 233**

**AN ORDINANCE REGULATING THE USE OF STREETS SURROUNDING THE PUBLIC MARKET IN CONNECTION WITH THE CONSTRUCTION OF THE NEW TWO (2)-STOREY MARKET BUILDING.**

**ON MOTION** of Hon. Juan Miguel M. Flores and duly seconded by Hon. Serafin N. Clavel II


**BE IT ORDAINED** by the Sangguniang Bayan of Oton, Iloilo, that:

- Section 1. Introductory Clause.** The demolition of the old market building and the construction of a two-storey building in the frontage of Oton Public Market will start on May 16, 2011.
- Section 2. One – Way Streets.** All streets surrounding the Oton Public Market shall be one-way streets upon commencement and during the duration of the above-stated project.
- Section 3. Temporary Stalls.** The shoulder and portion of Bonifacio Street along the Public Market shall be utilized for temporary stalls of stall owners affected by the project.
- Section 4. Installation of Signs.** There shall be installed traffic signs on all surrounding streets of the market so as to guide drivers and the public. They shall be installed by the Municipal Engineering Office (MEO) in coordination with the Oton PNP Station.
- Section 5. Repealing / Amending Clause.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby amended or modified accordingly for the time being.
- Section 6. Effectivity Clause.** This Ordinance shall take affect upon approval.
- Section 7. Copies.** This Ordinance shall be furnished to the Office of the Mayor; Barangays Poblacion South and East; MEO; Oton PNP Station; MEEDO and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.


