**ORDINANCE NO. 2012 – 247**

**AN ORDINANCE TEMPORARILY CLOSING THE STREETS COMPOSING THE ROUTE OF THE KATAGMAN FESTIVAL OPENING SALVO PARADE ON APRIL 28, 2012 AND THE STREET DANCING AND BALANGAY COMPETITIONS ON MAY 3, 2012.**

**ON MOTION** of Hon. Rodolfo Z. Alconga, Jr. which was duly seconded by Hon. Juan Miguel M. Flores

**BE IT ORDAINED** by the Sangguniang Bayan of Oton, Iloilo, that:

**SECTION 1. INTRODUCTION.** The celebration of the 440<sup>th</sup> Foundation Day of this Municipality will be highlighted by various activities especially "Balangay Contest" of competing balangays from the different barangays of Oton wherein several streets shall be temporarily closed during the celebration.

Rule VIII, Article 45 of the Implementing Rules and Regulations (IRR) of RA 7160 states that, "an LGU may through an Ordinance permanently and temporarily close or open any road, alley, park or square within its jurisdiction."

Rule VIII, Article 45 of IRR of RA 7160 states that "(a) any national or local road, alley, park or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs or undertaking of public works and highways, telecommunication and waterworks projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order;

**SECTION 2. REGULATED ACTS.**

- Southern and Northern bound private and public vehicles shall pass through Diversion Road, San Jose Road, Claro M. Recto, Burgos, Benedicto, and JC Zulueta Streets during the Opening Salvo Parade on April 28, 2012 from 7:00 AM to 10:00 AM and during the Balangay Contest and Street Dancing Competition on May 3, 2012 from 2:30 PM to 9:00 PM.
- Portion of Claro M. Recto, General Luna, FC Zulueta, Flores Streets, and portion of JC Zulueta Street (in front of Oton Catholic Cemetery to the Public Market), Bonifacio and Lopez Jaena Streets shall be temporarily closed on April 28, 2012 for the Opening Salvo Parade.
- Rizal Street Extension and the Road in front of the Catholic Church shall be declared temporarily closed on May 3, 2012 to accommodate the props of the competing balangays.
- Claro M. Recto, Mabini, J.C. Zulueta (in front of the Public Market), Bonifacio and portion of Lopez Jaena Streets shall be declared temporarily closed on May 3, 2012 for the Street Dancing Competition.
- There shall be PNP personnel and Traffic Aides to man the above described areas for direction and rerouting of all passing vehicles.
- The GSO in coordination with the PNP shall provide proper road signs for the convenience of the general public

**SECTION 3. EFFECTIVITY.** This Ordinance shall take effect upon approval.

**SECTION 4. COPIES.** This Ordinance shall be furnished to the Office of the Mayor; Oton PNP; Barangays Poblacion West, Poblacion South, Poblacion East and Poblacion North; LIGA ng mga Barangay; SKMF; GSO; OMPDC; and the Sangguniang Panlalawigan of Iloilo for information and guidance.
