ORDINANCE NO. 2012 – 251

AN ORDINANCE TEMPORARILY CLOSING F.C. ZULUETA STREET FROM JUNCTION OF BURGOS STREET TO JUNCTION OF GENERAL LUNA STREET, THIS MUNICIPALITY STARTING SEPTEMBER 19, 2012 TO NOVEMBER 30, 2012 FOR THE CONCRETING OF THE SAID STREET.

AS PROPOSED by Vice Mayor Jose Neil P. Olivares, **ON THE MOTION** of the Committee on Peace and Order and Public Safety composed by Hon. Rodolfo Z. Alconga, Jr., Hon. Jafet P. Salinas, and Hon. Margarito T. Clavel III which was duly seconded by Hon. Serafin N. Clavel II

BE IT ORDAINED by this Sanggunian, that:

SECTION 1. INTRODUCTION. The dilapidated condition of F.C. Zulueta Street in Barangay Poblacion West necessitates a prompt action for its concreting. Thus, this Sanggunian appropriated a total of Php 2.2 Million Pesos for the concreting of the said street through Resolution Nos. 2012-095 and 2012-148 with an appropriation of Php 800,000.00 and Php 1.4 Million, respectively.

SECTION 2. Section 21 of RA 7160 is explicit in providing that a local government unit may, pursuant to an ordinance permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction.

SECTION 3. By virtue of the aforesaid provision of RA 7160, for purposes of public works undertaken by this LGU, F.C. Zulueta Street is hereby declared temporarily closed from September 19, 2012 to November 30, 2012. The temporary closure shall be effected from junction of Burgos Street to junction of General Luna Street.

SECTION 4. Police Traffic Officers including the Traffic Aides through the Chief of Police shall adopt traffic alternative measures so that the public especially motorists shall be guided accordingly relative to the temporary closure of the portion of F.C. Zulueta Street.

SECTION 5. It shall be duty of the Municipal Engineering Office to make necessary traffic signages and install the same in junctions Burgos and General Luna Streets.

SECTION 6. All the streets adjoining F.C. Zulueta Street shall be considered substitute or alternative streets during the period of concreting as provided in section 3 above.


SECTION 7. This Ordinance shall take effect upon approval.


