**ORDINANCE NO. 2015 – 271**

**AN ORDINANCE AMENDING SECTION 3 ( I ) ( E) OF MUNICIPAL ORDINANCE NO. 2009 -18 (219), AN ORDINANCE APPROVING THE RE-ORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND PLANTILLA OF PERSONNEL AND THE CREATION OF THE MUNICIPAL ECONOMIC ENTERPRISE DEVELOPMENT OFFICE (MEEDO) OF THE MUNICIPALITY OF OTON, ILOILO.**

**ON MOTION** of the Committee on Legal Affairs, Human Rights and Local Governance composed by Hon. Juan Miguel M. Flores, Hon. Theodore C. Britanico and Hon. Margarito T. Clavel III which was duly seconded by Hon. Leonida C. Alison

**BE IT ORDAINED BY** the Sangguniang Bayan that:

**SECTION 1. INTRODUCTORY CLAUSE.**

- a. In the exigency of the service, there is a need of creating two (2) positions of Administrative Aide III and I in the Office of the Municipal Planning and Development.
- b. The abovementioned positions, once created and filled – up, will augment and do the necessary duties and functions in the planning and development operation of the said office.

**SECTION 2. AMENDATORY CLAUSE:** The following underlined items are amendments to Section 3 (I) E of Municipal ordinance No. 2009-18 (219):

1. Municipal Planning and Development Coordinator	-	1

4. Statistician	-	1
5. <u>Administrative Aide III (Salary Grade 3)</u>	-	<u>1</u>
6. <u>Administrative Aide I (Salary Grade 1)</u>	-	<u>1</u>

**SECTION 3. REPEALING CLAUSE.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE.** If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.

**SECTION 5. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.

**SECTION 6. COPIES.** This Ordinance shall be furnished to the Office of the Mayor, HRMO, MPDO, Acctg, MBO, MTO and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
