ORDINANCE NO. 2015 – 275

AN ORDINANCE TEMPORARILY CLOSING SEVERAL STREETS ON THE DATES INDICATED HEREIN AND PROVIDING A TEMPORARY ROUTING SCHEME IN RELATION TO KATAGMAN FESTIVAL 2015 AND 443RD FOUNDATION ANNIVERSARY.

ON MOTION of Hon. Eusebio G. Villavicencio, Jr. which was duly seconded by Hon. Leonida C. Alison

BE IT ORDAINED by this Sangguniang Bayan, that:

SECTION 1. INTRODUCTION. The celebration of the 443rd Foundation Day of this Municipality will be highlighted by various activities especially “Balangay Contest” wherein several streets shall be temporarily closed during the celebration.

Rule VIII, Article 45 of the Implementing Rules and Regulations (IRR) of RA 7160 states that, “an LGU may through an Ordinance permanently and temporarily close or open any road, alley, park or square within its jurisdiction.”

Rule VIII, Article 45 of IRR of RA 7160 states that “(a) any national or local road, alley, park or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs or undertaking of public works and highways, telecommunication and waterworks projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order.”

SECTION 2. REGULATED ACTS.

- A. April 26 – 27 and May 3 – 4.
 - A.1. Rizal Street Extension shall be temporarily closed on April 26 – 27 and May 3 – 4, 2015 purposely for transient vendors during market day.
- B. April 28.
 - B.1. Portion of C.M. Recto, Mabini, F.C. Zulueta, Del Pilar, Rizal and J.C. Zulueta Streets shall be temporarily closed from 7:00 AM to 10 AM for the Opening Salvo Parade.

- B.2. Temporary Route – Southern and Northern bound private and public vehicles shall pass through Diversion Road, San Jose Road, Claro M. Recto, Burgos, Benedicto, and JC Zulueta Streets.
- C. May 3.
 - C.1. Rizal Street Extension and the Road in front of the Catholic Church shall be declared temporarily closed to accommodate the props of the competing balangays.
 - C.2. Portion of Claro M. Recto, Mabini and J.C. Zulueta (from front of the Public Market to Batiano Bridge) Streets shall be declared temporarily closed on May 3, 2015 from 2:00 to 9:00 PM for the Street Dancing and Theater Competitions.
 - C.3. Temporary Route – Southern and Northern bound private and public vehicles shall pass through Diversion Road, San Jose Road, Claro M. Recto, Burgos, Benedicto, and JC Zulueta Streets during Street Dancing and Theater Competitions on May 3, 2015 from 2:30 PM to 9:00 PM.
- D. The duration of closures of national roads / highways shall be specified by the LCE in a written order by virtue of Rule VIII Article 45 of IRR of RA 7160.
- E. There shall be PNP personnel and Traffic Aides assigned to man the above described areas for direction and temporary routing of all passing vehicles.
- F. The MDRRMO in coordination with the PNP shall provide proper road signs for the direction and convenience of the general public

SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon approval.


