ORDINANCE NO. 2015 – 283

AN ORDINANCE TEMPORARILY CLOSING A PORTION OF RIZAL STREET ADJACENT TO THE PLAZA FROM NOVEMBER 30 TO DECEMBER 9, 2015 IN RELATION TO THE CELEBRATION OF ANNUAL PATRONAL FIESTA.

ON MOTION of Hon. Eusebio G. Villavicencio, Jr. which was duly seconded by Hon. Rodolfo Z. Alconga, Jr.

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. INTRODUCTION. Rule VIII, Article 43 of the Implementing Rules and Regulations (IRR) of RA 7160 states that, "an LGU may through an Ordinance permanently and temporarily close or open any road, alley, park or square within its jurisdiction."

Rule VIII, Article 45 of IRR of RA 7160 states that "(b) any LGU may temporarily close and regulate the use of any local street, road or thoroughfare or public place where shopping malls, Sunday markets, flea or night markets or shopping area may be established and where goods, merchandise, foodstuff, commodities or articles of commerce may be sold and dispensed to the general public."

SECTION 2. REGULATED ACTS.

1. Portion of Rizal Street, adjacent to the Plaza shall be declared Temporarily Closed from November 30 to December 9, 2015.
2. All motor vehicles, both public and private passing the abovementioned portion of Rizal Street shall temporarily pass any accessible or convenient route.
3. There shall be installed traffic signs for the information of everybody.

4. There shall be PNP Personnel and Traffic Aides to man the above-described area for direction and rerouting of all passing vehicles.
5. The GSO in coordination with the PNP shall provide proper road signs for the convenience of the general public.


SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon approval.

SECTION 4. COPIES. This Ordinance shall be furnished to the Office of the Mayor; Oton PNP; MDRRMO; Barangays Poblacion West, and Poblacion North; GSO; MPDO for information and guidance and the Sangguniang Panlalawigan of Iloilo for review.
