**ORDINANCE NO. 2015 – 285**

**AN ORDINANCE AMENDING ORDINANCE NO. 2014–267,  
AN ORDINANCE PRESCRIBING THE SAFETY  
MEASURES IN STORING, HANDLING, IGNITING,  
SELLING AND USING OF FIRECRACKERS OR  
PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR  
DEVICES IN THE MUNICIPALITY OF OTON.**

**ON MOTION** of Hon. Jafet P. Salinas which was duly seconded by Rodolfo Z. Alconga, Jr.

**BE IT ORDAINED** by the Sangguniang Bayan of Oton, Iloilo, that:

**SECTION 1. Rationale.** The Sangguniang Panlalawigan of the Province of Iloilo has reviewed Municipal Ordinance No. 2014–267, this Municipality, through SP Resolution No. 2015–024 entitled: "Resolution Adopting the Report of the Committee on Public Order and Safety and Approving its Recommendation Remanding Ordinance No. 2014–267 of the Municipality of Oton, Province of Iloilo entitled: An Ordinance Prescribing the Safety Measures in Storing, Handling, Igniting, Selling and Using of Firecrackers or Pyrotechnic Devices and such other Similar Devices in the Municipality for appropriate correction and / or revision to conform with Sections 447 and 59 of the Local Government Code of 1991 as corrected." This Sanggunian amends this ordinance, specifically its Penalty Clause.

**SECTION 2. Amendatory Clause.** In order to conform to Sections 447 and 59 of the Local Government Code of 1991, Section 8 of the said ordinance shall be amended as follows:

**SECTION 8. Penalties.** Violation of any of the provisions of Section 4 of this Ordinance shall be penalized of a fine of Two Thousand Five Hundred Pesos (Php2,500.00) or imprisonment of not less than 15

days and not more than 30 days or both fine and imprisonment at the discretion of the court.

**SECTION 3. Repealing Clause.** All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 4. Separability Clause.** If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.


**SECTION 5. Effectivity Clause.** Based on Section 511 of the Local Government Code, this Ordinance with penal sanctions shall take effect either on the day following its publication, or at the end of three (3) consecutive weeks period of posting, whichever occurs later.

**SECTION 6. Copies.** This Ordinance shall be furnished to the Office of the Mayor; Oton PNP; MTC; MEEDO; MTO; Actg.; MBO; GSO and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.


