ORDINANCE NO. 2016 – 287

AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 2015 – 280, AN ORDINANCE PRESCRIBING A UNIFORM COLOR CODE TO SPECIFIC ROUTE OF TRICYCLES-FOR-HIRE (TCH) IN THE MUNICIPALITY OF OTON, AMENDING FOR THIS PURPOSE MUNICIPAL ORDINANCE NOS. 1996-41 AND 2007-182 AS AMENDED.

ON MOTION of the Committee on Public Facilities and Utilities composed by Hon. Eusebio G. Villavicencio, Jr., and Hon. Juan Miguel M. Flores and duly seconded by Hon. Rodolfo Z. Alconga, Jr.

Be it ordained by the Sangguniang Bayan ng Oton that:

SECTION I. Introduction. There is a need to amend Section 3 of Ordinance No. 2015-280 AN ORDINANCE PRESCRIBING A UNIFORM COLOR CODE TO SPECIFIC ROUTES OF TRICYCLES FOR HIRE IN THE MUNICIPALITY OF OTON AMENDING FOR THIS PURPOSE MUNICIPAL ORDINANCE NO. 1996-41 AS AMENDED. The said amendments were the result of the committee hearing conducted by the committee on Public Utilities and Facilities last February 10, 2016 where the color code of Pob. Oton – Sta. Rita – Sta. Monica – Cadinglian – Turog-turog vice versa shall be changed from princess pink to Candy Pink 123. Also there is a need to add a prescribed color code to specific route of Poblacion Oton – Buray – Sta. Rita – Sitio Catugpan of Sta. Monica – Caboloan Norte and vice versa (Blue Green).

SECTION 2. Amendatory Clause: The following underlined items shall be the amendments:

SECTION 3. TRICYCLE-FOR-HIRE PRESCRIBED ROUTES AND CORRESPONDING COLOR CODE:

6. Poblacion, Oton – Buray – Sta. Rita – Sta. Monica – Cadinglian – Turog-turog and vice versa **CANDY PINK 123**

16. Poblacion, Oton – Buray – Sta. Rita – Sitio Catugpan of Sta. Monica – Caboloan Norte and vice versa (BLUE GREEN)

SECTION 3. Repealing Clause. All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 4. Separability Clause. If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.

SECTION 5. Effectivity Clause. This Ordinance shall take effect upon approval.




