ORDINANCE NO. 2016 – 290

AN ORDINANCE REPEALING ALL PROVISIONS FOR COMMUNITY SERVICE IN THE PENALTY CLAUSE OF ALL ORDINANCES.

AS PROPOSED by Vice Mayor Jose Neil P. Olivares, **ON MOTION** of Hon. Juan Miguel M. Flores which was duly seconded by Rodolfo Z. Alconga, Jr.

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. Introductory Clause. Many existing ordinances in the records of this Sanggunian have penalty clauses providing for community service as one of the penalties.

Section 447 (a) (1) (III) of the Local Government Code provides: (III) approve ordinances imposing a fine not exceeding Two Thousand Five Hundred Pesos (Php2,500.00) or an imprisonment for a period not exceeding Six (6) months or both in the discretion of the court, for the violation of a municipal ordinance.

Premises considered, considering that community service is not provided by RA 7160 as a form of penalty, this ordinance is necessary.

SECTION 2. Repealing Clause. All provisions for community service as a form of penalty in the penalty clause of all municipal ordinances are hereby repealed.

SECTION 3. Effectivity Clause. This ordinance shall take effect upon approval of the local chief executive.
