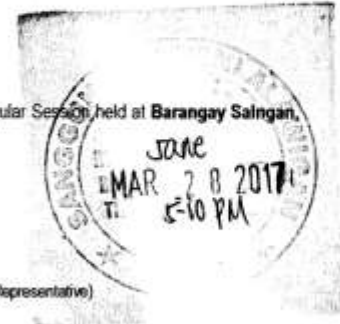

ORDINANCE NO. 2017 – 300

AN ORDINANCE AMENDING ORDINANCE NO. 2000-75 (ARTICLE XII, SECTION 1) ON THE CREATION OF THE TRAFFIC MANAGEMENT COORDINATION COMMITTEE OF THE MUNICIPALITY OF OTON, ILOILO.

AS PROPOSED by Hon. Eusebio G. Villavicencio, Jr. **ON MOTION** of the Committee on Public Utilities and Facilities composed by Hon. Eusebio G. Villavicencio, Jr., Hon. Margarito T. Clavel III, Hon. Juan Miguel M. Flores which was duly seconded by Hon. Lorna T. Geonigo

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. Introductory Clause. The Oton Traffic Management Coordination Committee is tasked to evaluate the planning and implementation of traffic management programs in this Municipality. This would be the coordinating body to review and approve the traffic engineering and management scheme and recommend to the Sangguniang Bayan for the passage of Resolutions and Ordinances relative to the traffic and routing of common carriers operating in the Municipality of Oton. The Traffic Management Coordination Committee was created through Ordinance No. 2000-75 entitled: An Ordinance Enacting the Traffic Code in the Municipality of Oton, Iloilo and Providing Penalties for Violation Thereof.

The Municipal Disaster Risk Reduction Management Office (MDRRMO) of Oton is mandated in Traffic Management Framework Plan which shall be responsible for traffic operations for an efficient traffic mechanism, for proper order of operation and enactment of traffic ordinances setting directives and development in this Municipality.

The MDRRMO is now tasked by the Local Chief Executive (LCE), thus this Ordinance.

SECTION 2. Amendatory Clause. The underline are the amendments to this Ordinance.

Section I. The Municipality of Oton Traffic Management Coordination Committee.

A coordination body to be known as the Municipality of Oton Traffic Management Coordination Committee, hereinafter referred to as the Committee is hereby created which shall be composed of twelve (12) members, including the Chairman and Vice Chairman who shall be

designated by the Honorable Mayor from among the members. Membership of the committee shall consist of six (6) persons selected by the Mayor from the private sectors and six (6) ex-officio members only.

1. SB Member, Chairman Committee on Public Utilities and Facilities
2. Chief of Police, Oton PNP Station
3. Police Officer in Charge of Traffic
4. Municipal Engineer
5. Municipal General Services Office
6. Municipal Disaster Risk Reduction Management Office.

SECTION 3. Repealing Clause. All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 4. Separability Clause. If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.


SECTION 5. Effectivity Clause. This Ordinance shall take effect upon approval.

SECTION 6. Copies. This Ordinance shall be furnished to the Office of the Mayor; PNP; MEO; GSO; MDRRMO; and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
