ORDINANCE NO. 2018 – 321

AN ORDINANCE TEMPORARILY CLOSING PORTIONS OF STREETS IN OTON, ILOILO ON MAY 3, 2018 FROM 3:00PM TO 7:00PM FOR THE STREET DANCE COMPETITION DURING THE KATAGMAN FESTIVAL 2018 AND IN CELEBRATION OF THE 446TH FOUNDATION ANNIVERSARY OF THE MUNICIPALITY.

ON MOTION of Hon. Eusebio G. Villavicencio, Jr. which was duly seconded by Hon. Rodolfo Z. Alconga, Jr.

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. INTRODUCTION. The celebration of the Katagman Festival and 446th Foundation Day of this Municipality will be highlighted by various activities which will culminate on May 3, 2018 through a Street Dancing Competition of the Balangay tribes wherein several streets shall be temporarily closed during the celebration.

Rule VIII, Article 45 of the Implementing Rules and Regulations (IRR) of RA 7160 states that, "an LGU may through an Ordinance permanently and temporarily close or open any road, alley, park or square within its jurisdiction."

Rule VIII, Article 45 of IRR of RA 7160 states that "(a) any national or local road, alley, park or square may be temporarily closed during actual emergency or fiesta celebrations, public rallies, agricultural or industrial fairs or undertaking of public works and highways, telecommunication and waterworks projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order."

SECTION 2. REGULATED ACTS.


- A. **May 3, 2018** – Portions of A. Mabini, J.C Zulueta, Bonifacio, Rizal, Lopez Jaena and C.M. Recto Streets, Oton, Iloilo shall be temporarily closed from 3:00 PM to 7 PM for the Street Dance Competition.
- B. **Temporary Route** – Southern bound private and public vehicles shall pass through Diversion Road, San Jose Road, Bangga Favian, turn right to CM Recto St left turn to del Pilar St or Burgos St. going to JC Zulueta St; while Northern bound private and public vehicles going to Iloilo City shall pass through JC Zulueta Street left turn to General Luna St. going to Bangga Favian and pass through San Jose Road, Diversion Road going to Barangay San Antonio. This is applicable from 3:00 PM to 7:00 PM of May 3, 2018.
- C. The duration of closures of national roads / highways shall be specified by the LCE in a written order by virtue of Rule VIII Article 45 of IRR of RA 7160.
- D. There shall be PNP personnel and Traffic Aides assigned to man the above described areas for direction and temporary routing of all passing vehicles.
- E. The MDRRMO in coordination with the PNP shall provide proper road signs for the direction and convenience of the general public


SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon approval.

SECTION 4. COPIES. This Ordinance shall be furnished to the Office of the Mayor; Oton PNP; MDRRMO; Barangays Poblacion West, Poblacion South, Poblacion East, Poblacion North and San Antonio; Liga ng mga Barangay; GSO; MPDO; Assessor's Office; Tourism Office for information and guidance and the Sangguniang Panlalawigan of Iloilo for review.
