ORDINANCE NO. 2018 – 323

AN ORDINANCE TEMPORARILY CLOSING SITIO TUBURAN, BRGY. TRAPICHE ROAD GOING TO BRGY. CALAM-ISAN, OTON, ILOILO FOR THE KALAH-CIDSS NCDDP-DSWD PROJECT: THE IMPROVEMENT OF RURAL ACCESS THROUGH COMMUNITY-MANAGED CONCRETING OF ROAD.

ON MOTION of the Committee on Public Utilities and Facilities composed by Hon. Eusebio G. Villavicencio, Jr., Hon. Margarito T. Clavel III, and Hon. Juan Miguel M. Flores duly seconded by Hon. Ma. Loma T. Geonigo

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. INTRODUCTION.

The Municipality of Oton, Iloilo is one of the recipient of KALAH-CIDSS NCDDP-DSWD project wherein Brgy. Trapiche, Oton availed the said project with a funding of P8, 381, 913.74 under subproject title: Improvement of Rural Access Through Community-Managed Concreting of Road with a total length of 1.3 kilometers, 5 meters width and 20 cm thickness located at Sitio Tuburan, Brgy. Trapiche going to Brgy. Calam-isan, Oton, Iloilo.

Due to the given timeline by the National Project Management Office of the KALAH-CIDSS, the said subproject should be 100% physically complete on or before June 30, 2018 otherwise the LGU will shoulder the payment for its completion, thus, there is a need to temporarily close the said road for the continuous implementation of the project to reach its completion.

As provided in Section 21 of RA 7160, (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction x x x; c) Any national or local road, alley, park, or square may be temporarily closed during x x x an undertaking of public works and highways, x x x, the duration of which shall be specified by the local chief executive concerned in a written order: x x x.

SECTION 2. REGULATED ACTS.

1. Brgy. Road from Sitio Tuburan, Trapiche going to Brgy. Calam-isan, Oton, Iloilo with a length of more or less 1.3 kilometers shall be temporarily closed during the implementation of the subproject with title: Improvement of Rural Access Through Community-Managed Concreting of Road until KALAH-CIDSS – NCDDP June 30, 2018; After concrete pouring for 15 days shall be closed to any kinds of vehicle; after which, it shall be open to any light vehicles and after 28 days, the said road will be open for use of the motorist.
2. There shall be installed traffic signages for the information of everybody.
3. There shall be Barangay Tanod Personnel and/ or Traffic Aides to man the above-described areas for direction and rerouting of all passing vehicles.
4. The Barangay concerned shall provide proper road signs for the convenience of the general public including the rerouting schemes and its signages.


SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon approval.


