RESOLUTION NO. 2018 – 004

RESOLUTION ALLOWING THE ILOILO PROVINCE PAROLE AND PROBATION OFFICE NO. 1, PAROLE PROBATION ADMINISTRATION, REGIONAL OFFICE NO. 6, DEPARTMENT OF JUSTICE TO LEASE AN OFFICE SPACE AT THE OTON ARCADE BUILDING AND AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO SIGN FOR AND IN BEHALF THE MUNICIPALITY OF OTON, ILOILO THE A MEMORANDUM OF AGREEMENT FOR LEASE OF OFFICE SPACE.

WHEREAS, the Iloilo Province Parole and Probation Office (IPPPO) No. 1, Parole, Probation Administration Regional Office No. 6, Department of Justice (DOJ) had manifested an intention to lease an office space at the Oton Arcade Building specifically Stall No. 18 owned by the Municipality of Oton;

WHEREAS, as per Section 444 of the Local Government Code of 1991 the Local Chief Executive has the power to allocate and assign office space to municipal and other officials and employees who by law or ordinance, are entitled to such space in the Municipal Hall and other buildings owned or leased by the Municipal Government;

WHEREAS, the Iloilo Parole and Probation Office No. 1 requested this LGU to lease said stall without leasehold rights considering that the IPPPO is a government office which deliver services to the people;

WHEREAS, as agreed and reflected through Committee Report 2018-02, the MOA to be signed by the Local Chief Executive (LCE) and the Iloilo Province Parole and Probation, Parole and Probation Administration Office, Region 6, DOJ shall contain the following:

- 1) No leasehold right required;
- 2) Contract of Lease is renewable annually;
- 3) Rental rates of stall for year 2018 is Php3,500.00 per month and for years thereafter the rent will follow the rate indicated in the latest Municipal Tax and Revenue Code of the Municipality of Oton.

NOW THEREFORE on motion of the Committee on Ways and Means composed by Hon. Grace Marie Escanlar-Cruz, Hon. Ma. Lorna T. Geonigo, and Hon. Juan Miguel M. Flores which was duly seconded by Hon. Lee C. Alison, be it


RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan ng Oton, Iloilo to pass this Resolution Allowing the Iloilo Province Parole and Probation Office No. 1, Parole Probation Administration, Regional Office No. 6, Department of Justice to Lease an Office Space at the Oton Arcade Building and Authorizing the Local Chief Executive to Sign for and in Behalf of the Municipality of Oton, Iloilo a Memorandum of Agreement for Lease of Office Space.


