**RESOLUTION NO. 2018 – 005**

**RESOLUTION EXTENDING THE TIME OF PAYMENT OF LOCAL TAXES, FEES AND CHARGES WITHOUT SURCHARGES OR PENALTIES UNTIL JANUARY 31, 2018.**

**WHEREAS**, per report of the Municipal Economic and Enterprise Office (MEEDO) and Municipal Treasurer’s Office, the renewal of business permits and application of new businesses in this Municipality have reached 21%;

**WHEREAS**, the Local Chief Executive has requested this Sanggunian to extend the time of payment of business taxes without surcharges or penalties until January 31, 2018 citing the reasons of low percentage of renewal of business permits, and for the purpose of encouraging the business sector to process its business permits on the first month of the year;

**WHEREAS**, Section 167 of the Local Government Code provides: Time of Payment – Unless otherwise provided in this Code, all local taxes, fees, and charges shall be paid within the first Twenty (20) days of January or of each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months.

**WHEREAS**, finding the request justifiable, this Sanggunian hereby grants said request.

**NOW THEREFORE** on motion of Hon. Grace Marie E. Cruz which was duly seconded by Hon. Eusebio G. Villavicencio, Jr., be it

**RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Bayan ng Oton, Iloilo to pass this Resolution Extending the Time of Payment of Local Taxes, Fees and Charges Without Surcharges or Penalties Until January 31, 2018.
