FLORES TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF OTON, ILOILO A SUPPLEMENTAL MEMORANDUM OF AGREEMENT WITH THE AGRICULTURAL TRAINING INSTITUTE, REGIONAL TRAINING CENTER VI OF THE DEPARTMENT OF AGRICULTURE IN THE ENHANCEMENT OF FITS CENTERS FOR THE RICE CROP MANAGER (RCM).

WHEREAS, as an ICT – based extension modality, the Agricultural Training Institute (ATI) as the lead agency in implementing extension services of the Department of Agriculture (DA) is keen on bridging the gap of farmers' access to RCM by tapping its network of FITS Centers nationwide;

WHEREAS, the FITS Center is a component of the Techno Gabay Program institutionalized to the LGUs and being coordinated by ATI by virtue of the Implementing Rules and Regulations of Executive Order 801;

WHEREAS, 10 selected FITS Centers in the region including the FITS Oton will be enhanced with RCM as one of the main services and at the same time the FITS staff will be tapped to conduct assessment on the impact of RCM to farmers' users yield, as well as change in farmers' attitude and perception in using RCM;
