RESOLUTION GIVING CASH INCENTIVE IN THE AMOUNT OF FIVE THOUSAND PESOS (PHP5,000.00) TO MR. JOSE NAPOLES FRESNO FOR RETURNING TO THE OWNER THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND PESOS (PHP120,000.00) AND PERSONAL THINGS LEFT IN HIS TAXI.

WHEREAS, as per record of the Office of the Investigative Section of La Paz Police Station, the record of event revealed that on February 24, 2018, Jose Napoles Fresno, driver of Sam-Sam Taxi with Plate Number PWY 339 appeared to the Station and turned-over to his passenger Silvary Delight Gastafies, resident of Palawan State University, Barangay Tinigaban, Puerto Princesa City, Palawan, one (1) pouch red color containing cash amounting to One Hundred Twenty Thousand Pesos (Php120,000.00) and ATM Cards of different banks which were left behind in the taxi of Mr. Fresno at around 11:45 AM of the same day;
