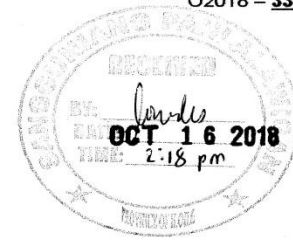

ORDINANCE NO. 2018 - 332

AN ORDINANCE CREATING THE DIFFERENT PLANTILLA POSITIONS IN THE MUNICIPALITY OF OTON, ILOILO THEREBY AMENDING MUNICIPAL ORDINANCE 2009-18 (219) ENTITLED "AN ORDINANCE APPROVING THE RE-ORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND PLANTILLA OF PERSONNEL AND THE CREATION OF THE MUNICIPAL ECONOMIC ENTERPRISE DEVELOPMENT OFFICE (MEEDO) OF THE MUNICIPALITY OF OTON, ILOILO," AS AMENDED AND ORDINANCE NO. 2014 - 260, AN ORDINANCE CREATING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE.

ON MOTION of the Committee on Legal Affairs, Human Rights and Good Governance composed by Hon. Juan Miguel M. Flores, Hon. Vanessa T. Salinas, Hon. Jafet P. Salinas and duly seconded by Hon. Lee C. Alison

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that

SECTION 1. Introduction.

The Local Government Code of 1991 provides in its Section 447 (1) (vii) the power of the Sangguniang Bayan, to wit: Subject to the provisions of this Code and pertinent laws, determine the powers and duties of officials and employees of the municipality; and (viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government.

The Municipal Mayor requested for the creation of four (4) positions of different offices for more efficient operations of the Municipal Government to be effective in 2019. There is a need to have additional necessary personnel in concerned offices in order to meet the demands of its constituents in delivering basic services.

SECTION 2. AMENDATORY CLAUSE. The following plantilla positions shall be created and shall form as amendments to:

SECTION 3. LIMITATION ON THE FILLING–UP OF POSITION. Newly created positions may only be filled up if the Budget for Personal Services of the Municipality does not exceed the 45% PS ceiling.

SECTION 4. REPEALING CLAUSE. All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.

SECTION 6. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.

SECTION 7. COPIES. This Ordinance shall be furnished to the Office of the Mayor; Administrator; HRMO; CSC Region VI; MPDO; Actg.; MBO; MTO; MLGOO; all local offices concerned; and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
