RESOLUTION REQUESTING THE HON. AGUILINO Q. PIMENTEL, JR., MINISTRY OF LOCAL GOVERNMENT, MANILA, PHILIPPINES FOR THE IMMEDIATE RELEASE OF THE ADDITIONAL INTERNAL REVENUE ALLOTMENT (IRA) OF THE MUNICIPALITY OF OTON, PROVINCE OF ILOILO.

WHEREAS the Municipality of Oton is entitled to additional Internal Revenue Allotment;

WHEREAS the release of the allotment is direly needed in order to implement Circular 28 which would initially comply with the implementation of Cost of Living Allowance (COLA) of the officials and employees of this Municipality;

WHEREAS the release of the said allotment would also be needed in the grant of one-month year-end bonus to officials and employees of this Municipality which has long been denied by the previous regime;

WHEREAS the delay in the release of this allotment would deny our officials and employees who are under paid benefits to which they are badly in need in this time of our economic crisis.

NOW THEREFORE on motion of Hon. Emigdio T. Acosta, duly seconded by Hon. Romeo B. Canto, be it




