5. Improvement of MPP, Pob. East 10,504.00
6. Sports Development of 6 barangays 9,000.00
7. Lupon Training. 8,540.00
8. Skills Training for Brgy. Captains, Secretaries, and 1 Councilman 4,500.00
9. Reserve for Management Tool 18,281.97
