RESOLUTION AUTHORIZING THE MUNICIPAL TREASURER TO DISBURSE THE AMOUNT OF THREE THOUSAND PESOS (P3,000.00) TO BE USED FOR THE ONE-DAY SYMPOSIUM IN CONNECTION WITH THE NATIONAL RECONCILIATION AND DEVELOPMENT PROGRAM CHARGEABLE TO HUMAN RESOURCE DEVELOPMENT PLAN CURRENT YEAR 1987 OF THE 20% IRA FUND.

WHEREAS, in order that the Executive Order No. 103 of President Corazon C. Aquino be implemented;

WHEREAS, the Oton Municipal Reconciliation and Development Council is holding a one-day Symposium for the rebel returnees/sympathizers;

WHEREAS, Memo Circular No. 87-04, of the Department of Local Government, authorized the utilization of the 20% IRA development fund for program/activities concerning rebel returnees/sympathizers who signified their intention to return to the fold of the law.
