RESOLUTION REQUESTING FOR FINANCIAL AID OF TWO HUNDRED SEVENTEEN THOUSAND PESOS (P217,000.00) FROM THE HONORABLE SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT, MANILA, FOR THE IMPLEMENTATION OF CIRCULAR NO. 29.

WHEREAS, pursuant to Circular No. 29 dated August 5, 1987 of the Joint Commission of Local Government Personnel Administration, Manila, modifying the salary rates of the Career Executive Officers as provided for in Executive Order No. 152 and adjusting by two (2) steps all rank in file employees;

WHEREAS, in implementing said salary rate the officials and employees of this Municipality, who are only enjoying the rates under Circular No. 13 step five (5) will be greatly benefitted;

WHEREAS, its implementation will uplift their morale as their present rate cannot commensurate the increasing high cost of living;

WHEREAS, the present income of the Municipality (5th Class) cannot cope up the required deficiencies for its implementation;

WHEREAS, we, the officials of the present administration are finding ways and means to implement the said circular so that our employees can avail a better pay and can enhance their performance in the name of good public service.

NOW THEREFORE, on motion of Hon. Antonio Ecube and duly seconded by Hon. Geronimo Carreon, be it

RESOLVED as it is hereby resolved to request for financial aid in the amount of TWO HUNDRED SEVENTEEN THOUSAND PESOS (P217,000.00) from the National Government through the Honorable Secretary, Department of Budget and Management, Manila for the above mentioned purpose.

RESOLVED FURTHER to furnish a copy of this resolution to the Office of the Sangguniang Panlalawigan, Province of Iloilo for information.
