ORDINANCE NO. 2022 – 383

AN ORDINANCE TEMPORARILY CLOSING BRGY. MAMBOG ROAD (FROM OTON-SAN-JOSE NATIONAL ROAD UP TO THE BOX CULVERT GOING TO BRGY. CABOLOAN SUR) FOR FIFTEEN (15) DAYS FOR THE PURPOSE OF CONCRETING THE FIFTY-EIGHT (58) METERS ROAD.

As requested by the Local Chief Executive, ON MOTION of Hon. Vanessa T. Salinas which was duly seconded by Hon. Ella Mae S. Yeoh

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. INTRODUCTION.

The Local Government Unit of Oton, Iloilo programs to concrete the Brgy. Mambog Road, a 58 meters long with 4 meters wide Brgy. Road, sourced from its 20% Development Fund.

Pursuant to the Implementing Rules of R.A No. 7160 of Local Government Code of 1991, on Rule VIII, Article 45, Temporary Closure – (a) any National or Local road, alley, park or square may be temporarily closed during x x x x undertakings of public works and highways x x x x the duration of which shall be specified by the Local Chief Executive concern in a written order x x x x (3) when public works projects or activities are being undertaken for a period as may be determined necessary for the safety, security, health or welfare of the public, of which such closure is necessary to facilitate completion of the project or activities.

SECTION 2. TEMPORARY CLOSURE OF BRGY. MAMBOG ROAD. The Brgy. Mambog Road (from Oton-San Jose National Road to the Box Culvert going to Brgy. Caboloan Sur) shall be temporarily closed to all vehicles due to public works (concreting of road) for Fifteen Days from January 21, 2022 until the end of construction.

SECTION 3. DETOUR. In connection with the foregoing provision to avoid inconvenience to the riding public in the course of work, all vehicles going to or from Brgys. Caboloan Sur, Caboloan Norte and Bitá Norte, Oton, Iloilo shall take the alternate route of Bitá Sur - Caboloan Sur Road or Bitá Sur-Bitá Norte Road vice versa

SECTION 4. PUBLIC INFORMATION AND GUIDANCE. In order to guide the public, there shall be installed signages and billboards of temporary nature and materials which shall be provided by the Municipal Engineering Office/ contractor, if any, informing the commuters of the temporary closure of Brgy. Mambog Road; ensuring the alternate route is passable to the commuting public. It shall also responsible for the proper dissemination of information in compliance to Municipal Ordinance No. 1997 -54, an Ordinance Requiring the Installation of Information Board on all infrastructure projects undertaken in the Municipality of Oton.

The Barangay concerned shall be responsible in the rerouting scheme. Barangay tanods and / or traffic aides of the municipality shall also help in the implementation of the said measure as to the continuous and orderly flow of traffic.

SECTION 5. Effectivity Clause. This Ordinance shall take effect upon approval.

SECTION 6. Copies. This Ordinance shall be furnished to the Office of the Mayor; Oton PNP; MEO; MPDC, MDRRMO; Barangays Mambog, Caboloan Sur, Caboloan Norte, Bitan Norte and Bitan Sur, Oton; OFTODA; CAMBITODA and the Sangguniang Panlalawigan of Iloilo for information, guidance and review respectively.
