ORDINANCE NO. 2022 – 384

AN ORDINANCE GRANTING THE EXTENSION OF TIME OF PAYMENT OF BUSINESS TAXES AND PERMIT WITHOUT SURCHARGES / PENALTIES UNTIL FEBRUARY 15, 2022 IN THE MUNICIPALITY OF OTON, ILOILO, AMENDING SECTIONS 282 AND 283 OF MUNICIPAL ORDINANCE 2013-256.

AS REQUESTED BY the Local Chief Executive, **ON MOTION** of Hon. Anna Rena Ponsaran Trespeses Chair, Committee on Ways and Means, which was Unanimously seconded by all the members present,

BE IT ORDAINED by the Sangguniang Bayan of Oton, Iloilo, that:

SECTION 1. RATIONALE: The country is still under the state of national calamity as we are greatly affected by the COVID – 19 Pandemic, devastated by Typhoon Odette last December 2021 and a conflagration that happened at the Oton Public Market; Aside from the health aspect as being affected by this Pandemic and natural calamities, the business sector also suffers much which needs the extended help of the LGU to boost back their economic strength which will also increase livelihood;

According to Section 167 of the Local Government Code of 1991 x x x x “The Sanggunian concerned may for a justifiable reason or cause, extend the time of payment of such taxes, fees or charges without surcharges or penalties, but only for a period not exceeding six (6) months”;

It is provided in the **Municipal Ordinance no. 2013-256**, “**AN ORDINANCE ENACTING THE REVISED MUNICIPAL TAX AND REVENUE CODE OF THE MUNICIPALITY OF OTON FOR FISCAL YEAR 2014 AND ONWARDS**” as amended, on **Section 282 Time of Payment**. “Unless specifically provided herein, all taxes, fees, and charges imposed in this Ordinance shall be paid within the first twenty (20) days of January or each subsequent quarter as the case may be”. **Section 283. Surcharge for Late Payment**. “Failure to pay the tax described in this Article within the time required shall subject the taxpayer to a surcharge of twenty-five percent (25%) of the original amount of tax due, such surcharge to be paid at the same time and in the same manner as the tax due”.

SECTION 2. AMENDATORY CLAUSE:

The time of payment of all taxes, permit fees, and charges shall be extended up to February 15, 2022 without surcharges or penalties amending Sections 282, and 283 of Municipal Ordinance no. 2013-256.

SECTION 3. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval and will be valid until February 15, 2022.


SECTION 4. REPEALING CLAUSE. All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby modified accordingly.


SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is held invalid, the other provisions not affected thereby shall continue in operation.


